IN 2016

In accordance with Civil Service Rules and Regulations, please accept this correspondence as an official request to conduct an entry-level firefighter examination process to establish an entry-level firefighter eligibility list in 2016.

Due to recent retirements and in anticipation of additional retirements in the near future, we expect the need to fill several vacancies.

Based on the number and timing of retirements or resignations that may occur, vacancies may be filled from an entry-level list. The most recent entry-level firefighter list expired on September 19, 2015. Vacancies in 2016 have been filled from a lateral entry-level firefighter eligibility list, which has been exhausted. If it is determined that a need exists to hire entry-level firefighters, a current eligibility list will need to be in place to begin the hiring process.

Should I determine the need to hire entry-level firefighters, the department would prepare an Entry-Level Firefighter job announcement based on the following minimum qualifications and scoring which have not changed since the last entry level hiring process.

#### Minimum qualifications:

- Be at least 18 years of age by date of hire
- Have a high school diploma or GED Certificate
- Be a U.S. Citizen with the ability to read and write the English language
- Must be in appropriate physical condition and meet medical standards as established by the City of Bellevue Fire Department
- Have a valid Washington driver's license by date of hire (and ability to maintain)

#### Additional details of the exam process and scoring are as follows:

- Written exam is conducted by Public Safety Testing.
- Candidates must pass a Candidate Physical Assessment Test (CPAT).
- Oral Interview is conducted by the Fire Department.
- Candidates are ranked on 60/40 scale (Oral board/written exam), then Military preference points (if applicable) are added to determine ranking on eligibility list.

I am requesting permission to begin the process to rehire Mike Lombardo a previous employee of the department who left in good standing June 5, 2015, which falls clearly within the 5 year window. 2009 Civil Service Rules governing this situation are found under Section 4.03 Reemployment. For situations where the department desires to rehire;

"At the request of the appointing authority and upon approval by the Civil Service Commission, any person who has resigned in good standing, and who has attained permanent status prior to separation may, within five years of the effective date of his/her separation, be reemployed in an entry level position provided that he/she can successfully pass the examination, and provided there are no employees of the same department who have been laid off and whose names appear on a reemployment list for the department. Persons reentering the classified service through reemployment must complete a one year probationary period in order to regain permanent status. Seniority and continuous service in the department will be counted only from the reemployment date. Previous service will not be restored to seniority."

Mr. Lombardo resigned due to a disability; therefore, this request is subject to the successful completion of an updated background check, medical evaluation and psychological exam. Upon successful completion of the above, he will be returned to duty, which will include a retraining program and a one year probationary period.

Upon your approval, it is our intent to make a conditional offer of employment utilizing the above criteria.
