#### PRESENTATION & DISCUSSION:

Lalita Uppala – IAWW, Vice President and Community Program Director

India Association of Western Washington (IAWW) operates in the Greater Seattle area to help form a cultural, social and educational organization for the advancement, appreciation, performance, reservation, study and/or teaching of the performing arts (music, drama, dance, film-arts), and languages for the Indian community. They also provide a common identity to the Indian community through promotion of unity, friendship and good will based on mutual understanding and cooperation. Their objectives also include promoting and providing social, educational and cultural programs which will enable children of Indian heritage to understand Indian traditions and lastly to encourage and foster the activities that improve mutual

understanding and appreciation between the Indo-American community and the mainstream American community.

The IAWW Community Program was established in March 2015 by the India Association of Western Washington and a group of community patrons to address wellness, civic engagement, vocational mentoring and workshops for women, and early childhood education for families. Immigrant families experience significant isolation because of drastic changes in lifestyle, culture, language, traditions, and weather. The intent is to provide the Asian Indian community of Greater Seattle, a common platform to connect and integrate into the mainstream community.

They have established a memorandum of understanding with the city of Bellevue which allows to run a pop-up community center at North Bellevue Community Center every Thursday and similarly a second pop up center at the Sammamish Teen Center every Monday. From June to September of each year, they will be at the new Redmond Community Center at Marymoor Park.

IAWW hopes to extend these pop-up centers to provide the community with a platform and a space to connect while they identify the needs of our community and address them through resource referral and cultural navigation programs providing legal services, transportation, insurance, career needs in addition to addressing voter awareness and engagement.

Thursdays at North Bellevue Community Center often include:

10.30 a.m. – Meditation, Conversational English, Women's Fitness

11.30 a.m. – Chair Yoga

12.30 p.m. – Community Lunch

1.30 p.m. – Informational Sessions, Music, Bingo, Art, Cultural Education

2.00 p.m. – Preschool Enrichment (3+ years)

Evening programs include bridge club, community conversations, Music Therapy for Autism Spectrum Children (2nd Thursdays), ANVI Women's Workshops, Legal Clinics etc.
