150th Avenue SE Congestion Reduction Project

January 2019

150th Avenue SE: SE Newport Way to SE 38th Street

The Transportation Department is looking to ease afternoon traffic congestion along 150th Avenue SE and improve pedestrian safety.

Project Features:

- Add an 800-foot southbound to westbound right-turn lane at the intersection of 150th Avenue SE and SE Newport Way;
- Install a new sidewalk with curb and gutter next to the new right-turn lane along the west side of 150th Avenue SE;
- Build retaining walls on the west side of 150th Avenue SE at the north and south ends of the project to accommodate the roadway widening; and
- Replace 800 feet of existing rockery on the east side of 150th Avenue SE with a new block wall and provide a new six-foot sidewalk with curb and gutter. (Funded by the Major Maintenance Program.)

Project Schedule:

The project design is expected to be completed in early 2019 with construction beginning in

spring 2019. Project updates will be mailed to nearby properties.

Project Funding:

Capital Investment Program, Neighborhood Safety, Connectivity and Congestion Levy, and the Major Maintenance Program.




