May is Bike Everywhere Month, an annual activity that attracts thousands of participants and encourages casual bicyclists to ride more.

May also marks progress on

several projects intended to make bicycling safer and more accessible for the general population. To help keep up with recent changes, the city has updated its Bellevue bike map. Advisory - Please ride safely; drivers, expect more bicyclists on the road and stay vigilant.

Bike Month in Bellevue is a collaboration between the City of Bellevue, King County Metro, Sound Transit, Cascade Bicycle Club and the Bellevue Downtown Association. Here are some highlights:

- Bike Everywhere Challenge, May 1-31: The Challenge (http://wabikes.org/growing-bicycling), sponsored by Washington Bikes, is a fun and free competition.
- Bike to School Day, Wednesday, May 9: Take part in the nationwide Bike to School Day (https:// www.cascade.org/). Locally, families can learn more about Bellevue's School Pool program (http://www.chooseyourwaybellevue.org/schoolprograms) and what schools are participating. School Pool is a partnership that encourages sustainable transportation options.
- F5 Bike Everywhere Day, Friday, May 18: In Bellevue from 6-9 a.m., Choose Your Way Bellevue will host celebration stations at the Bellevue Transit Center and on the I-90 Trail in Enatai. TransManage and the City of Kirkland will host a station on the SR 520 Trail at Evergreen Point.

# Shelter Land Use Code Amendment **Process Continues**

Following a concentrated public outreach process throughout March and April, the City Council is set to further discuss



a proposed citywide Land Use Code Amendment (LUCA) for shelters. A draft LUCA was presented to councilmembers during the April 23 extended study session. Additional discussion on the topic is tentatively scheduled for the following meeting dates (all briefings will take place at City Hall. More details on exact times will be available in the future):

- May 7
- May 21
- June 11 (public hearing)

The council has set a goal of developing citywide shelter LUCA adoption by the August recess. The Land Use Code is a permitting tool that governs the location, design and approval process for development in the city. A LUCA will add regulations to the code to determine how and where a homeless shelter can be sited in Bellevue.

# **Enhancement Program**

Northwest Bellevue residents: let us know how you'd like to spend \$300k in your neighborhood area! The Neighborhood Enhancement Program (NEP), the \$5 million, city-funded, capital improvements program that provides Bellevue residents the opportunity to propose and select projects that improve their neighborhood's quality of life and enhance its character, is currently in the Northwest Bellevue neighborhood area.

It's now time for Northwest Bellevue area residents to submit project ideas by returning the prepaid NEP project request form that each household received last month in the mail or by using the online project request form found on the NEP website, <a href="https://www.bellevuewa.gov/nep">https://www.bellevuewa.gov/nep</a>.

Project ideas must be received by Monday, May 28. City staff will then review the proposed ideas and present those that are feasible at a public Open House at the Bellevue Boys & Girls Club on Thursday, September 12.

The NEP program rotates through the City's 14 NEP Neighborhood Areas, serving two areas each year. The \$5 million NEP budget is allocated to each designated Neighborhood Area based on the number of households in each area.

Come join us for an enjoyable, non-competitive, recreational ride for the whole family. The 7th Annual Lake to Lake Bike Ride starts and finishes at the Lake Hills Community Park. The event

benefits Bellevue Youth Camp Scholarship Fund.

There are two unique routes that take riders through Bellevue's award-winning park system exploring hidden treasures of Bellevue: a mostly flat 9-mile Greenbelt Loop route and the Lake Loop which is a more challenging 22-mile route. Both routes are approximately 80 percent on-road and 20 percent offroad gravel. This event is recommended for ages 9 and up. Riders under age 9 must be on a tandem, in a tag-along or trailer. Volunteers are needed.

Entry fees are low. Participants receive a custom "buff". Pre-registration is welcome and participants will pay a \$15 entry fee instead of the \$20 entry fee on the day of the event. # Bellevue Achieves High Marks with STAR Communities Rating

that the City of
Bellevue has
been awarded
a 4-STAR
Community

Rating for national leadership in sustainability. The city joins a small group of communities in the nation to receive this recognition from STAR Communities for its participation in the program. The nonprofit organization helps evaluate the livability and sustainability of American cities and counties.

Communities pursuing STAR certification accumulate points for their achievements across seven goal areas, which are used to determine their rating. These areas range from "climate and energy" to "economy and jobs" to "equity and empowerment."

There are three STAR certification levels: 3-STAR Community (250-449 points); 4-STAR Community (450-649 points); or 5-STAR (650+ points). During the evaluation process, Bellevue racked up an impressive score of 549.07.

"Bellevue is the 'city where you want to be' and you can see that reflected in our 4-STAR Community rating," said Mayor John Chelminiak. "Being nationally recognized as a sustainable community further demonstrates our commitment to supporting a healthy environment, strong economy and well-being for all residents in Bellevue."

Several efforts stood out among Bellevue's sustainability and livability initiatives. These highlights include:



- 73 percent of Bellevue residents live within 1/3 of a mile walk to a park, open space or trailhead.
- Bellevue's 19 acres of parkland per 1,000 residents greatly exceeds the STAR target of seven acres.
- Per capita greenhouse gas emissions and energy usage in the city are declining.
- Bellevue has a number of programs and incentives in partnership with Puget Sound Energy to reduce energy use.
- The number of businesses in Bellevue is growing, contributing to the city's low unemployment rate.
- Bellevue's schools are safe and educational quality is high, as measured by school violence statistics, thirdgrade reading scores and overall graduation rates.
- Bellevue residents are highly educated with 66 percent of those 25 years and over having a bachelor's degree or higher.
- Bellevue's Diversity Initiative provides a comprehensive approach to increasing equity, celebrating diversity and building cultural competency.
- Access to and support for the arts and cultural amenities is high in Bellevue and in the region.
- Bellevue's Human Services Needs Update and associated funding strives to meet the needs of Bellevue's vulnerable populations.

"The STAR rating process gives cities a roadmap for how they can refine and improve their operations to drive continuous improvement," said Hilari Varnadore, executive director of STAR Communities. "The City of Bellevue should be applauded for its commitment to sustainability, and for the clarity and transparency provided while achieving its goals."

The STAR Community Rating System was initiated and supported by founding partners ICLEI-Local Governments for Sustainability USA, the U.S. Green Building Council, National League of Cities and the Center for American Progress. Its work is supported through community subscriptions and generous foundation grants from these national philanthropic organizations.

It's spring cleaning time! You can also feel good knowing that everything you drop off will be recycled at Bellevue's Annual Spring Recycling Event. Don't miss it, this is Bellevue's only collection event for 2018.

#### What's accepted:

If you haven't been able to find a second life for the following items, please make sure they are safely secured when you are transporting them to the event with tarps, rope, straps, netting or other means. Only cars, passenger vans and pickups are allowed to drop off items. No flatbed or dump trucks are allowed. We reserve the right to refuse oversized, commercial or contaminated loads.

#### Cash-only fee for the following items:

- Appliances and scrap metal (\$33 for air conditioners, \$28 for refrigerators and freezers, \$5 for water heaters with insulation coating)
- Mattresses and box springs (\$15 per item)
- Porcelain toilets and sinks (\$15 per item)
- Residential propane tanks (\$5 per item) and small, empty camping tanks (\$1)
- Tires (limit six for the following: \$1 for each tire, \$3.50 for each tire on a rim, \$5 for each large truck tire, and \$15 for each truck tire on a rim)

#### Other items accepted include:

- Auto parts (metal and non-greasy)
- Appliances (such as blenders, dishwashers, dryers and washing machines, microwaves, stoves, and toasters)
- Clean scrap wood (untreated and unpainted)
- Electronic equipment (DVD and VCR players, cell phones, computer keyboards and mice, copiers, fax machines, printers, scanners, and stereos)
- Exercise equipment
- Lawnmowers (drain oil and gasoline, remove batteries for electric)
- Lead acid batteries (car, truck, marine and motorcycle)
- · Metal lawn furniture

- Rigid plastics (such as buckets, children's toys, coolers, laundry baskets, plastic lawn furniture, PVC pipe, and sports bottles)
- Styrofoam blocks and packing peanuts (white blocks and packing peanuts of any color)

#### Secure shredding of confidential materials:

Limit 5 file-sized boxes no larger than 15 inches long, 10 inches wide, and 12 inches high

# Where is Roadway Construction this Month?

106th Avenue Northeast & Northeast 6th Street Intersection Project

This project implements the Downtown Transportation Plan objective to "...improve the pedestrian environment and make walking the easiest way to get around Downtown." It will provide a continuous pedestrian facility between the Eastside Rail Corridor and Meydenbauer Bay.



When this project is built, it will raise the intersection (in height by six inches and in length by 200 feet) and provide additional on-street parking on both sides of 106th Avenue NE within the project limits. The project will also replace the existing traffic signals; install bollards along the raised section of roadway; replace existing sidewalks, widen the crosswalks and improve roadway markings.

Construction is underway and will be complete by the end of June. Work hours will be Monday through Friday, 7 a.m.-6 p.m., Monday through Friday.

When this project begins, the contractor will be closing Northeast 6th Street west of 106th. This means that drivers will not be able to exit eastbound onto 106th during the duration of the project.

Please make note that there will be a full 21-day roadway closure of the Northeast 6th and 106th intersection. The estimated time frame will be between the last week of May to the end of June. During the closure, pedestrians, bicyclists and drivers will need to follow the guidance of flaggers or uniformed police officers. For drivers, there will be intermittent lane closures before and after the full closure. Watch for electronic message boards for actual dates.

This construction will take place at a popular pedestrian crossing in Bellevue. Bicyclists and pedestrians, please be cautious and be aware of your surroundings as you walk in the area. If possible, use an alternate route. Drivers, please expect traffic delay

# 140th Avenue Northeast: Northeast 5th Street & Southeast 5th Street Curb Ramp Improvements



This project will improve pedestrian connectivity and safety by installing a new rapid flashing crosswalk system at 140th Avenue Northeast & Northeast 5th Street with improved curb ramps. The rapid flashing crosswalk system will feature LED lights that flash to increase driver awareness

of pedestrians using the crosswalk. This project will also improve the curb ramp on the west side of 140th Avenue Southeast & Southeast 5th Street.

Construction is expected to start early May and be completed by early June, weather permitting. Work hours are 8:30 a.m. to 3:30 p.m., Monday through Friday.
