**WELCOME TO YOUR
BELLEVUE PARKS & COMMUNITY SERVICES BOARD
MEETING**

Most Parks & Community Services Board business is conducted in public, and citizens are most welcome to watch and listen.

In order to hold a meeting, a quorum of at least four Boardmembers must be present. The Board follows the City Council's example, which operates under its own Rules and Procedures, and conducts its meetings according to *Robert's Rules of Order*.

Boardmembers may add items to the meeting's agenda for discussion or action, with a majority vote of those present, at the time when the agenda is approved.

Before any agenda item can be acted upon, the Chair will call for a motion to take action on that item. After the motion is seconded, the Board discusses the arguments for and against the motion.

Sometimes a Boardmember will propose a different course of action on a subject on the agenda. This is called a substitute motion and also requires a second. After discussion, the substitute motion is voted upon first. If a majority of the Boardmembers vote for the substitute motion, it passes and the matter is completed. If the substitute motion fails to obtain a majority, the Board returns to the original motion and continues to discuss and vote on it.

Other times, a Boardmember may wish to change a pending motion in some way. This is called an amendment. It also requires a second and is voted upon before a vote is taken on the main motion. If the amendment passes, the main motion is then voted upon "as amended." If the amendment does not receive a second or a majority vote, the main motion, as originally proposed, is voted upon.

When necessary, the Board may recess to an executive session. During these closed sessions, the Boardmembers are limited, by law, to discussing only such items as personnel issues, property acquisition and disposition; or to receiving advice from legal counsel on pending or potential litigation. The Chair or Vice-Chair will announce both the reason for any executive session and the anticipated time when the Board will return.

1. **CALL TO ORDER:**

The meeting was called to order by Chair Heath at 6:01 p.m.

2. **APPROVAL OF AGENDA:**

Motion by Boardmember Nieuwenhuis and second by Boardmember Synn to approve the meeting agenda as presented. Motion carried unanimously (6-0) to approve the agenda.

Chair Heath noted that Boardmember Van Hollebeke requested to participate in tonight's meeting remotely, since he is currently in New York City and not able to be physically present at the meeting.

Motion by Boardmember Synn and second by Vice-Chair Kumar to approve remote participation for Boardmember Van Hollebeke at tonight's meeting. Motion carried unanimously (7-0).

3. **APPROVAL OF MINUTES:**

Motion by Vice-Chair Kumar and second by Boardmember Nieuwenhuis to approve the October 11, 2016 Parks & Community Services Board Regular Meeting Minutes as presented. Motion carried unanimously (7-0).

4. **ORAL COMMUNICATIONS/PUBLIC COMMENTS:**

Chair Heath reminded Boardmembers about Vision 672 (7 Park Boardmembers, providing 8 volunteer hours per month, for 12 months out of the year, which equals 672 hours). Chair Heath would like Boardmembers to make decisions with sufficient information. He added that the Park Board's work need to be intentional, process and goal driven, and decisions need to be made with integrated and meaningful work.

Betsi Hummer, East Bellevue Community Council
14541 SE 26th Street, Bellevue, WA

On behalf of the East Bellevue Community Council (EBCC), Ms. Hummer distributed a copy of her presentation that was provided to City Council regarding the Larsen Lake restrooms. She made an official request to Council to keep the restrooms at Larsen Lake open year-round. Ms. Hummer was pleased to report that Council supports this request and will allocate the appropriate funding.

Ms. Hummer noted that she reviewed the Park Board meeting minutes over the past several years (starting in the 1970s), which reflected intentional work. She expressed her concern that Larsen Lake is a major wetland zoned residential area. However, it is currently recommended as commercially zoned. Ms. Hummer encouraged Boardmembers to evaluate the zoning and support residential zoning for the Larsen Lake community.

Lastly, Ms. Hummer reported that she recently attended a EBCC versus Puget Sound Energy hearing. She noted that Puget Sound Energy is questioning the validity of the Urban Boulevard Initiative. Ms. Hummer urged Boardmembers to keep the gems of the streets free from unsightly utility poles.

Loretta Lopez, 13419 NE 33rd Lane, Bellevue, WA
Bridle Trails Community Club

Ms. Lopez encouraged Boardmembers to request funding for the Bridle Trails 140th Avenue NE Neighborhood Park. She reminded Boardmembers that the community is in support of this project and a Master Plan is complete for the project.

5. **DIRECTOR'S REPORT:**

In response to previous Oral Communications and staff follow-up items, Mr. Foran provided the following report:

- There was a recent communication sent to Council regarding the Kelsey Creek playground. Staff is monitoring any Council decisions.
- Council did not approve funding for the restrooms to be open year-round at Larsen Lake. However, Council did request further information from staff regarding park facility restrooms that are open and/or closed throughout the year.

- In regards to the Mercer Slough and Enatai Beach Park being utilized for the East Link Project, Councilmember Robertson had clarified at an earlier Park Board meeting that this is a Council issue, not a Park Board issue. Council is evaluating the information and will make any final decisions.

6. **BOARD COMMUNICATIONS:**

Vice-Chair Kumar enjoyed many Bellevue parks over the last month, while walking her dog.

Boardmember Grindeland recently visited Ivanhoe Park.

Boardmember Synn spent time over the last month reviewing the budget.

Boardmember Deng attended the Great Pumpkin Hunt at Northwest Arts Center as well as the ice arena meeting. She will also be graduating next week from the Bellevue Essentials Program.

Boardmember Nieuwenhuis commended the Parks Department for resolving the drainage issues on the pathways around Larsen Lake. He also recently attended the ice arena meeting and meeting regarding the proposed men's shelter in the Eastgate area.

Boardmember Van Hollebeke commended staff for listening to the community and being willing to amend the plans, based upon community feedback, for the Kelsey Creek playground.

7. **CHAIR COMMUNICATION:**

In response to some of the confusion expressed at previous Board meetings regarding the relationship between the Park Board and the Human Services Commission, Chair Heath met with the Chair of the Human Services Commission to gain some perspective about the two Boards.

8. **DISCUSSION/ACTION ITEMS:**

A. **Budget/CIP**

Mr. Sanner provided an overview of the Preliminary 2017-2023 Capital Investment Program (CIP) Plan and the Council process until budget adoption in December. He also summarized the proposed memo from the Park Board to City Council, which requests funding for neighborhood parks in Bridle Trails and Newport Hills.

Mr. Sanner noted that the proposed Budget/CIP includes a \$7M contingency fund that would be the source of funding for the two neighborhood parks, and also includes the following projects:

- Multicultural center feasibility study
- Pacific Northwest Ballet
- Housing Development Consortium

Motion by Boardmember Grindeland and second by Boardmember Kumar to approve the Park Board's memorandum to City Council on the 2017-2023 Parks Capital Investment Program.

Boardmember Synn reiterated his request to have the budget funding restored to the same levels that they were before the levy was passed. Voters approved the levy with the assumption that they were enhancing the park funding. Boardmember Synn views the proposed memo to Council as very limiting. In particular, the Spring District and Grand Connection are not mentioned in the memo. Boardmember Synn views the memo as too "small-picture" and thinks that the memo limits the Board's ability to ask for specific projects. He suggested that the Board request a specific budget allocation that allows the Board to appropriate the dollars rather than request budget amounts for specific projects. Boardmember Synn views a budget allocation as an opportunity where the Board can provide insight and direction, therefore bolstering its value and presence.

Motion by Vice-Chair Kumar and second by Boardmember Deng to amend the Parks Capital Improvement Program memo to Mayor Stokes and City Councilmembers and include a reference about the Grand Connection in page 2, paragraph 3 of the memo. At the question, motion carried unanimously (7-0).

At the question, motion carried unanimously (7-0) to approve the Preliminary 2017-2023 Parks Capital Improvement Program memo to Mayor Stokes and City Councilmembers as amended.

Chair Heath thanked staff for facilitating the budget process. On behalf of the Board, Chair Heath will attend the November 21, 2016 Council meeting where the Board's memo will be presented. In addition, Boardmembers would like to send an ongoing message to Council that more funding is needed for parks.

B. Park Board Development

Chair Heath provided highlights from his recent meetings with the Human Services Commission Chair. He noted that the Human Services Commission mainly provides the Needs Update and funding for the community. Mr. Smith added that the Needs Update provides a valuable perspective for the community, especially those in need. It also provides information about the community members that visit Bellevue park facilities and attend various community events.

Boardmembers requested that a template be prepared for them to establish bylaws. Chair Heath clarified that the City Attorney's Office is working on the project now. The City Clerk has stated that a template should be ready in December.

Chair Heath reminded Boardmembers that the Annual Holiday Celebration for the Park Board and Human Services Commission will be held on December 6, 2016. He stressed the importance of Boardmember attendance at the event.

Chair Heath proposed the following agenda items for the Board retreat:

- Bylaws, Policies and Procedures—topics may include:
 - Clarity around scope, roles and responsibilities of Board.
 - Threshold for what gets communicated to the Board.
 - What can the Board actually do?
 - What about the community services piece?
 - Pro-active strategy for establishing relationships.
- Work Plan—topics may include:
 - Understand allocation of time and resources necessary for forthcoming Council requests.
 - Plan for Board Retreat priorities:
 - Board Retreat priorities may include: a) Another way to approach the Board’s scope, roles and responsibilities; b) What can the Board actually do? c) What about the community services piece? d) Pro-active strategy for establishing relationships.
 - Prioritize value-added education:
- Big Vision—topics may include:
 - Alternative funding.
 - More park land in the Spring District.
 - Experience of homelessness.
 - Consistency with the long-term budget discussions and/or communication to Council

Boardmember Grindeland suggested that the Board also consider how to deal with protests/rallies, Pokémon Go or other crazes, etc.

Boardmembers agreed to conduct the retreat on Saturday, February 11, 2017 from 9:00 a.m. – 1:00 p.m. Mr. Foran expressed concern for the quick turnaround time between the retreat and the February Board meeting, particularly if staff action is needed for the meeting. Chair Heath clarified that the February Board meeting will most likely be a continuation of the Board retreat.

9. **BOARDMEMBER COMMITTEE/LIAISON REPORTS:**

Chair Heath announced that the Mayor appointed Vice-Chair Kumar to be the Park Board representative on the Grand Connection Citizens Advisory Committee. The committee will meet one time per month for approximately one year. Vice-Chair Kumar will provide updates as needed. Chair Heath mentioned that the Board will learn more about the Grand Connection in January.

ACTION REQUESTED

The Parks & Community Services Board will be briefed on the Wilburton-Grand Connection planning initiative, including work to date on the Grand Connection visioning and the anticipated work for the Wilburton Commercial Area.

The Parks & Community Services Board will be asked to provide their feedback and input regarding the project.

BACKGROUND

The Wilburton-Grand Connection planning initiative was launched on December 7th, 2015 as a Council priority. The project includes two primary elements, a re-visioning of the Wilburton Commercial Area and the visioning of the Grand Connection

Grand Connection

The Grand Connection is envisioned as a non-motorized corridor that will begin at Meydenbauer Bay, connecting with Old Bellevue, the Downtown Park, Downtown Bellevue, and crossing I-405 into the Wilburton Commercial Area, and interfacing with the Eastside Rail Corridor. Planning and Community Development contracted with Balmori Associates, a landscape and urban design firm, to develop a high level vision for the proposed route. This vision is to include an overarching identity for the route, cohesive design strategies; including but not limited to paving, vegetation, and weather protection; improvement of existing public spaces, and to provide alternatives to cross Interstate 405 into the Wilburton Commercial Area. The work was separated into two phases; Phase One from Meydenbauer Bay to the Transit Center, and Phase Two from the Transit Center to Eastside Rail Corridor, including the I-405 crossing.

Additionally the team of lead and sub-consultants have conducted public and stakeholder engagement to help prioritize and inform the design. To date, most of Phase One has been completed, and concepts for the I-405 crossing, Phase Two, are beginning to emerge. In April the City partnered with Bellevue Arts Museum to host a three day design charrette where over 70 architects, planners, engineers, and artists infused concepts and strategies into the project. Visioning for the Grand Connection is expected to conclude in the second quarter of 2017.

Wilburton Commercial Area

Historically referred to as “Auto Row” the Wilburton Commercial rests at the confluence of a number of planned transportation and infrastructure improvements. By 2023 the Wilburton East Link light rail station will provide service at the northern side of the study area. Additionally the East Main, Downtown, and Spring District stations will ensure that the entire study area will be within a transit walkshed. In addition to transit service the Eastside Rail Corridor will provide a non-motorized north-south spine through the entire study area. The Grand Connection is anticipated to interface with the Eastside Rail Corridor and provide an east-west connection to Downtown.

Combined with the planned transportation improvements, the Wilburton Commercial Area is positioned between Bellevue’s two high growth urban areas of Downtown and BelRed. This unique context encourages the Wilburton Commercial Area to become the next urban neighborhood of Bellevue. As such the city will launch a land use, urban design, transportation, and environmental analysis of the study area to create a new vision that capitalizes on the Wilburton Commercial Area’s unique context. This process will include analysis and recommendations to zoning, urban design, transportation, and parks and open space. As part of the public engagement, the City will form a Citizen Advisory Committee (CAC) to recommend a preferred alternative. The analysis and CAC are expected to be completed in the first quarter of 2018.

PARKS CIP PROJECT STATUS REPORT December 2016

Botanical Garden

We have worked with the BBG staff and Garden Society to develop a landscape plan for the front of the garden to integrate the existing wetland plantings, rock garden and pathway system with the future wetland-sun terraced gardens and Main Street streetscape improvements. The Garden staff has received a \$50,000 grant from King County to assist with construction costs, and the Garden Society has agreed to contribute \$175,000 to complete the project next spring.

CIP Budget

At their December 5 meeting, the City Council approved the 2017-23 Capital Investment Program (CIP). All initial requests have been funded, including continued funding for the Renovation Program and Planning & Design, as well as supplemental funding for Meydenbauer Beach Phase 1, Surrey Downs and Airfield Parks. Funding requests for Bridle Trails/140th Street, Newport Hills/Tyler, Ashwood Park and Lake Sammamish Park were not approved.

Congregation for the Homeless Temporary Center

Staff is working with the Congregation for the Homeless on a temporary men's shelter located in the City owned Lincoln Center building. Temporary housing for approximately 70 overnight guests have been accommodated to-date, with planning is underway to completing additional improvements, including a day center, next spring.

Downtown Park – Complete the Circle and Rotary Inspiration Playground Expansion

Construction is approximately 40% complete. Portions of the 100th Avenue parking lot opened for public use in mid-October, and work in the SE quadrant is underway, with utility work and tree removal complete, soil import and rough grading nearing completion and work on the terraced walls is underway. Retaining walls along the west and north sides of the Inspiration Playground have been installed. The SW plaza area is nearing completion. Electrical work is underway to accommodate additional promenade lighting. The Magic Season Ice Rink has been relocated to Ashwood Park and will remain open through the holiday season.

Grants

We were unable to reach an agreement with the Bellevue School District on the long-term use of the Ivanhoe Youth Theatre facility, so we have deferred the planned code compliance improvements in favor of limiting public use of this facility until an agreement can be reached. We have therefore declined the \$75k King County 4Culture grant to assist with these improvements.

We have submitted a letter of interest for a potential 2017 grant to replace the Wilburton Hill synthetic turf field and continue to work with RCO and the National Park Service to establish the requirements to accept a \$500k Federal grant for the Inspiration Playground.

Hidden Valley Sportsfield Improvements

Phase 1 improvements are now complete, and BWLL is paying for these improvements over a three year period. Phase 2 (picnic shelter) work is pending a funding commitment from the Little League. We are now working with the Boys & Girls Club to install recognition signage at the ballfields and to renovate the Field 1 scoreboard.

Kelsey Creek Playground Replacement

After several neighbors expressed concern about our proposed relocation of the Kelsey Creek playground, the staff completed additional analysis and concluded that the location was proper. With some minor modifications, we are proceeding as planned. This information has been shared with the neighbors and we expect construction will occur this spring.

Marymoor Park Transfer

We are working with our Utilities staff and representatives of King County and RCO to explore options to transfer the City-owned portion of Marymoor Park to King County to allow the County to enter into an agreement with a local soccer organization to redevelop the existing softball fields into a soccer complex.

Meydenbauer Bay Phase 1 Park Development

The design team has completed final construction documents and continues to work with City permit reviewers to make final tweaks to the plans. The final environmental permit from the Army Corps has finally been received, and plans remain on schedule to be out to bid the second week of January in anticipation of a May construction start. The sanitary sewer is scheduled to start construction the first week of January, and we have worked closely with the Utilities project staff to minimize impacts to the marina during construction.

- **Hidden Valley/Boys & Girls Club Partnership:** Complete
- **Lake Sammamish Neighborhood Park:** No activity.
- **Surrey Downs Park Development:** Design has re-started, and application for construction permits is expected this spring in anticipation of a 2018 construction start, subject to light rail construction progress. Staff is working with the adjacent neighbors to identify an appropriate boundary fence to install prior to construction.

Subject: Preliminary 2017-2023 Parks Capital Investment Program

Thank you for the opportunity to provide comments on the preliminary Parks 2017-2023 Capital Investment Program (CIP) Plan. We hope that these comments will be helpful to you as Council prioritizes the City's capital investment needs for the next seven years.

The Parks & Community Services Board reviewed the budget process and provided direction on Parks CIP proposals at our meetings in March and April. Board direction and priorities included:

- Continue the commitment to the voters from the 2008 levy, utilizing levy funds and the remaining City matching dollars to focus on Downtown Park, Surrey Downs, Property Acquisition, and Airfield Park design;
- Initiate the first phase of park development at Meydenbauer Bay;
- Maintain existing capital infrastructure, including both the Parks Renovation and Enterprise Facility improvement programs;
- Continue to invest in the ongoing planning of Bellevue's park and open space system, including funding for the Ashwood Master Plan.

While the above list can be accomplished with the additional Parks Levy and Real Estate Excise Tax revenue available in the updated plan, we do not believe that current Parks CIP funding sources are adequate to meet the needs of a growing and changing community. The Parks Levy program was not intended to represent all the capital needs of the community for a 20-year period (through 2028). The board identified four additional budget proposals in response to community requests and to fill gaps that exist in the current system that should not wait until the next levy program. The four new projects are described below:

- Tyler Park Development (\$1.5M). Design and construct a neighborhood park in Newport Hills on the Tyler/Patterson properties first acquired by the City in 2010.
- Bridle Trails/140th Street Park Development (\$1.75M). Design and construct a neighborhood park on the Ginzburg property acquired by the City in 2014.
- Lake Sammamish Park Master Plan & Design (\$0.75M). Develop a Master Plan and design for the future development of a neighborhood park on Lake Sammamish, an identified 2008 Parks Levy project.
- Ashwood Park Design & Permitting (\$0.5M). Design and permit the first phase of Ashwood Park construction upon completion of the site master plan.

At the November Park Board meeting, we reviewed the status of Parks capital budget proposals as included in the 2017-2023 Preliminary CIP (attached).

Overall, we are encouraged that the proposed 2017-2023 plan continues to make progress on the 2008 Parks Levy package that was overwhelmingly approved by Bellevue voters. In addition, the plan funds two major Council priorities to construct Meydenbauer Bay Phase I and the Downtown Park Circle/Gateway by the end of 2018 (Council Priority #9). Lastly, we believe it is vitally important to maintain existing infrastructure as proposed in the Renovation Plan, which helps provide major maintenance for Bellevue parks consistent with the expectations of our citizens.

Of the four Park Board projects that remain unfunded in the current plan, we want to specifically request funding for the proposed neighborhood parks in Newport Hills and Bridle Trails. We believe that additional neighborhood investment is an ongoing need, and is aligned with the budget outcome of Quality Neighborhoods and Council's priority for a high-quality built and natural environment. Both of these areas were specifically identified for additional neighborhood park development in the adopted 2010 and 2016 Bellevue Parks & Open Space System Plans, and both neighborhoods have existing undeveloped park property suitable for development. In the community survey that accompanied the plan, Bellevue residents included neighborhood parks in the top tier of park facilities that should be prioritized for additional development, and this statistical data has been corroborated by supportive citizen comments from both neighborhoods.

We understand that the Bellevue community has multiple needs and that there is never sufficient funding to accomplish everything you would like to during the budget process. We also understand that City Council has a priority to develop a long range financial strategy to explore options to address the future operating and capital needs of the City (Council Priority #24). While the list of capital needs facing the City is undoubtedly large, we encourage Council to dream big and develop a balanced and sustainable approach for advancing the City's long-term vision. In addition to completing the levy commitments and funding the larger Meydenbauer Bay Master Plan, additional funds will be needed to create parks in the Bel-Red area, provide additional green space in downtown Bellevue, the Grand Connection, and to create additional opportunities for the aquatics community.

As a city that prides itself as a "City in a Park," we acknowledge that parks contribute to the quality of life in Bellevue, creating a special place that families and business seek to locate and flourish. Research consistently shows that urban parks and recreation systems have positive economic impacts beyond a place to recreate and socialize with friends and family. Research shows that high quality, well-maintained parks contribute positively to the overall economic development of the City, including raising property tax values, attracting tourists, and protecting water and air quality.

Once again, we appreciate the ability to provide comments on the 2017-2023 Parks CIP Plan, and look forward to continued discussions as the budget process moves forward.
