1. **CALL TO ORDER:**

The meeting was called to order by Chair Kumar at 6:01 p.m.

2. **APPROVAL OF AGENDA:**

Motion by Boardmember Synn and second by Boardmember Clark to approve the meeting agenda as presented. Motion carried unanimously (6-0).

3. **APPROVAL OF MINUTES:**

Motion by Vice-Chair Trescases and second by Boardmember Synn to approve the July 10, 2018 meeting minutes as presented. Motion carried unanimously (6-0).

4. **ORAL COMMUNICATIONS/PUBLIC COMMENTS:**

None.

5. **COMMUNICATIONS FROM CITY COUNCIL, COMMUNITY COUNCIL, BOARDS AND COMMISSIONS:**

Chair Kumar welcomed newest Boardmember, Pamela Unger.

6. **DIRECTOR'S REPORT:**

Mr. Foran called attention to information included in the Board Packet regarding a recent proposal from the Boys & Girls Club of Bellevue to develop, in partnership with the City, an indoor youth sports program facility at Wilburton Hill Park, similar to the Hidden Valley Park partnership developed several years ago.

7. **BOARD COMMUNICATION:**

Vice-Chair Trescases received feedback from a citizen who is disappointed in Bellevue's wayfinding signs and suggested that they be linked to an online map.

Boardmember Synn visited several parks throughout Bellevue during the summer months and was impressed with how well the parks were utilized.

Boardmember Hamilton enjoyed the Parks Board tour of Meydenbauer Bay Park and Surrey Downs Park.

Boardmember Clark also enjoyed the Parks Board tour of Meydenbauer Bay Park and Surrey Downs Park. In addition, he enjoyed spending time at Lewis Creek Park and Downtown Park during the summer months.

Boardmember Unger visited many parks throughout the summer months, including: Downtown Park, Hidden Valley Park, Killarney Glen Park, and Wilburton Hill Park. She also enjoyed the Parks Board tour of Meydenbauer Bay Park and Surrey Downs Park, and attended the recent Grand Connection meeting.

8. **CHAIR COMMUNICATION & DISCUSSION:**

Chair Kumar attended the Grand Connection meeting. She also is looking forward to the NE Corner project at Downtown Park.

9. **BOARDMEMBER/COMMITTEE/LIAISON REPORTS:**

No reports.

10. **DISCUSSION/ACTION ITEMS:**

A. **Neighborhood Area Planning Program**

Ms. Munkberg explained that the Neighborhood Area Planning Program is a seven-year program to update neighborhood planning efforts. She noted that the Neighborhood Area Planning Program kicked off in August and has three pillars:

- Based on Comprehensive Plan
- Strategic, action-focused
- Ground-up community process

Ms. Munkberg discussed the relationship between the Neighborhood Area Planning Program and the Comprehensive Plan. The Comprehensive Plan includes the Neighborhood Area Planning Program and the Land Use Regulations. She added that within the Comprehensive Plan there is a neighborhood element that identifies the 16 neighborhoods throughout Bellevue. The overall goal is to determine how to help neighborhoods adapt to change, while preserving what is valued.

Ms. Munkberg explained that the neighborhood plans will be strategic and future focused. More specifically, the plan will include:

- Community profile
- Opportunities map
- Relationship to Comprehensive Plan
- Vision and strategies

Ms. Munkberg explained that the neighborhood plans will be completed in about a year. She reviewed the work program for the neighborhood plans and noted that they depend on a collaborative relationship between the city and residents. The first two neighborhood area plans to be updated are Northeast Bellevue and Northwest Bellevue.

Boardmember Unger inquired if there is a budget associated with the neighborhood plans. Ms. Munkberg discussed the process for getting neighborhood plan projects funded.

Boardmembers asked how they can be involved in the neighborhood planning efforts. Ms. Munkberg suggested that Boardmembers share in the outreach efforts and also act as sounding boards for community members.

Vice-Chair Trescases called attention to a letter included in the Board Desk Packet from Vernon Schrag regarding “Keep Ashwood Park Green.” Ms. Munkberg clarified that Ashwood Park is in the Downtown planning area and not part of the initial focus.

Boardmember Heath inquired if outreach efforts will be used to inform residents if their particular neighborhood falls short of national standards for how close they should live to a park. He suggested that this information be utilized to advocate for levies, etc. As neighborhoods are discussed, Boardmember Heath suggested that the Parks Board provide comments and make recommendations as necessary.

B. Aquatics Center Study

Mr. Foran recalled that the City conducted an Aquatic Center Feasibility Study in 2009 to assist the Council in determining whether it supports an aquatic facility. The study explored a range of options and operating models. He also described the renewed community interest in aquatics facilities, partnerships, and regional solutions. The 2009 Aquatic Center Feasibility Study explored the different types of facilities that could meet the demand, conducted a preliminary site analysis, completed a market analysis, conducted public outreach, and explored a range of financing options. The study was presented to the Council in 2009, and the Council expressed interest in Option D, a regional aquatic center, and directed staff to work with adjacent cities, school districts, and other potential partners. The effort was temporarily put aside, in part due to the recession.

Mr. Foran further added that the City of Kirkland placed a community and aquatic center proposal on the ballot in 2015, which the voters did not approve. The City of Redmond initiated public outreach in 2016 to study a range of facilities for community centers and aquatic centers. In 2017, the King County Parks Department convened a process to reexamine the viability of a regional approach for an Eastside facility. King County Councilmember Claudia Balducci secured approximately \$2 million to work toward a regional solution, and that process is ongoing. Mr. Foran noted direction from the City Council in May 2017 to continue to pursue local partnerships and opportunities.

Mr. Foran described the popularity of swimming and aquatic activities in Bellevue and on the Eastside. He reported that approximately 4,200 families are members of private outdoor pools in Bellevue, and 3,600 swimmers participate in more than 26 Eastside swim clubs. Mr. Foran said there are a number of private neighborhood pools and membership facilities in Bellevue. However, the Bellevue School District does not have water sports facilities. He noted that Kirkland and Redmond are served by older pools as well. Regional aquatic facilities that have been developed since 2011 include: 1) Snohomish Aquatic Center, 2) Lynnwood Recreation Center and Pool, 3) Sammamish Community and Aquatic Center, and 4) Rainier Beach Community Center and Pool. Those facilities serve a wide range of ages and types of activities.

Mr. Foran discussed a conceptual layout previously discussed with the Council that includes a leisure and recreation pool, competition pool, instruction and fitness pool, and a wellness/fitness/rehabilitation pool. He described how a movable bulkhead feature allows the facility to modify the configuration as needed.

Mr. Foran described the current King County regional process involving Bellevue, Kirkland, and Redmond to explore the range of funding and governing options (e.g., voted levies, voted/Councilmanic bonds, grants, private funding, and partnerships) and the potential for multiple facilities. There has been some discussion about developing a Metropolitan Parks District in which voters in each city would be asked to approve a taxing district. Mr. Foran said the Cities and King County executed a Memorandum of Understanding (MOU) which outlines the tasks to finish this work. In general, the work merges the independent efforts of the parties into a collaborative facility and program plan with recommendations for specific facility types

and sites, funding and governance. Mr. Foran clarified that exploring a regional approach through the MOU is not the only alternative. All alternatives to meet the aquatic needs for Bellevue and the region are being explored.

The sites previously reviewed in the City's feasibility study were Hidden Valley, Airfield Park, Marymoor Park, Bellevue Utility Site at Marymoor, SE Eastgate Way, Highland Park, Bellevue College and the Bel-Red corridor. Mr. Foran said an aquatic facility could be coordinated with the Grand Connection project, which would provide a tourism and family activity center. He said the Bellevue School District submitted a letter to the City indicating an interest in providing financial support to develop a facility that would accommodate the District's competitive swim programs. Bellevue College revised its campus master plan since 2009, and one component of their plan is a community partnership of some kind.

Mr. Foran discussed the following next steps:

- Finalize the scale and scope of the program elements and prepare a schematic drawing and architectural rendering.
- Update the estimated capital costs by program element.
- Update the estimated operating cost performance by program element.
- Conduct a site feasibility analysis for several sites (including Marymoor and Bellevue College).
- Propose a financing and operational plan that could include public/private/nonprofit partnerships.
- Prepare communication tools and conduct a public outreach process to include public meetings and presentations.

Vice-Chair Trescases requested that synchronized swimmers be considered when evaluating aquatic options. She clarified that there are specific depth requirements for synchronized swimming.

Mr. Foran explained that Council approved up to \$250,000 to develop more precise information to determine whether to proceed with an aquatic center. In addition, 10 firms submitted proposals in response to the City's RFQ. Four finalists have been selected for further evaluation. Mr. Foran noted that regional work is ongoing, as well as continued discussions with the Bellevue School District and Bellevue College. Strategies are also being developed to identify additional partners and sponsors.

There was a general discussion about aquatic revenue streams and whether or not most aquatic centers are able to cover their operating costs. Mr. Foran noted that the goal of the aquatic center is to operate at little or no deficit.

Boardmember Synn called attention to the Pacific Northwest's climate and the benefits of having an indoor aquatic center, particularly during the winter months.

Boardmembers discussed the various locations being considered for an aquatic center. Mr. Foran also noted that the advocacy group SPLASH Forward is assisting with helping the process.

11. **NEW BUSINESS:**

None.

12. **PROPOSED AGENDA FOR NEXT MEETING:**

Boardmember Unger requested an update be provided about Ashwood Park at a future Board meeting. Mr. Foran discussed the previous presentations that have been made to Boardmembers about Ashwood Park and suggested a written update might be more appropriate than a formal presentation, since there are no new updates. Boardmembers favored this option.

Boardmember Heath requested an update on Bellevue's efforts to address homelessness and how homelessness is impacting Bellevue parks.

Mr. Parker reported that the Pacific Science Center will provide a brief presentation at the next Board meeting to mark their 25 year anniversary at Mercer Slough. He also noted that King County will be conducting an open house for the Eastside Rail Corridor on the same night as the next Board meeting.

Staff is working on scheduling a joint meeting with the Arts Commission.

Boardmember Heath would like the Parks Board included in any neighborhood outreach sessions regarding the Neighborhood Area Planning Program.

Boardmember Clark noted that the Grand Connection has a high focus on young children and professionals but not on young teens (i.e., middle/high school aged). He requested that this age group be kept in mind during the planning efforts. Other Boardmembers agreed with this recommendation. Boardmember Hamilton added the Crossroads Community Center is a great facility for youth and could provide insight for the Grand Connection framework.

Motion by Boardmember Heath and second by Vice-Chair Trescases to extend the meeting until 8:35 p.m. Motion carried unanimously (6-0).

Subject: Mercer Slough Environmental Education Center programming update
(Informational – no Board action requested)

On Tuesday, October 9, 2017 at the Parks & Community Services Board meeting, we will present an update about the Mercer Slough Environmental Education Center (MSEEC). This presentation will update the board on the ongoing programming and facility use at MSEEC, the status of the Joint Use Agreement, fundraising efforts by the Pacific Science Center (PSC), and the 25th anniversary of programming at the site.

MSEEC was originally developed in 1993 in a partnership agreement between the City and the Pacific Science Center. 2018 marks the 25th anniversary of that partnership. The purpose of the MSEEC was to synergistically utilize the resources of each organization to deliver environmental education programs to help build community support and increase citizen appreciation and understanding of freshwater wetland ecosystems. Originally only PSC delivered programs out of the Sullivan House. In 2008, the site expanded to its current campus, utilizing 8 separate buildings and a connected trail system in Mercer Slough Nature Park to deliver environmental programming. 2018 also marks the 10th year of the Joint Use Agreement at the site and is the half-way mark for that 20-year agreement. Current, ongoing programming includes family and adult ranger programs, school field studies, an internship program for high-school students, an on-site preschool, and day camps during summer and school breaks. In addition to regular programming, the Community Room is available for rent through the Parks Scheduling Office, and is utilized by COB staff for meetings, and by public for private events including trainings, parties, weddings, business meetings, and religious gatherings. With all the ongoing events, MSEEC stays busy year-round.

In addition to our program update, we'd also like to share some photos of new exhibits that went into the Visitor's Center, and an idea to utilize an area designated for a classroom building to instead be used to build an outdoor classroom, to be used jointly by PSC and COB for programming, as well as a place for public use during non-programming hours.

We look forward to the opportunity to share this information with you.

RE: Partnership with the Boys & Girls Clubs of Bellevue (BGCB)

DIRECTION REQUESTED: No specific direction is being requested at this time. Tonight's agenda item initiates a formal review of the BGCB proposal which is intended to culminate in a Park Board recommendation to the City Council. The recommendation will address the questions of whether the City should continue to explore a potential partnership with the BGCB to construct and operate a fieldhouse, and if so, under what circumstances.

This memo includes basic background information relevant to the work necessary to thoroughly evaluate the proposal.

THE PROPOSED PARTNERSHIP

The Boys & Girls Clubs of Bellevue (BGCB) have proposed entering into a partnership with the City that would allow them to fund design, construction, maintenance and operation of an athletic fieldhouse on City property similar to our gymnasium partnership at Hidden Valley Park. Community use of the facility would be a collaboration between the BGCB and the City with each party providing programs unique to their respective program goals.

FACILITY SIZE AND PURPOSE

The fieldhouse would be designed to accommodate a broad spectrum of field sports traditionally held outdoors, but would extend practice, training and playing opportunities to year-round for activities such as lacrosse, soccer, cricket, field hockey, baseball, softball and parkour. An indoor facility would have the flexibility to accommodate both traditional field sports and non-traditional recreational programming and could provide a wide range of culturally relevant recreational opportunities such as cricket training to better serve the City's changing demographics.

Year-round opportunities for sports increases the capacity to serve more youth and teens in programs that provide physical activity, which is critical to both healthy lifestyle and academic success, as well as overall community health and wellness. Though designed mainly for youth and teens, all ages could be accommodated, and many uses and amenities are being explored.

The facility is proposed to be approximately 30-40,000 square feet in size. No design has taken place, so even a preliminary layout plan has not been developed. However, for general size comparison, South Bellevue Community Center is about 34,000 sf, the Hidden Valley Gym is 23,000 sf, Robinswood Tennis Center is 30,000 sf and most City community centers are about 20,000sf.

BACKGROUND

Boys & Girls Clubs of Bellevue

The BGCB is a non-profit organization that operates recreational programs and activities throughout Bellevue. The City and BGCB have worked together in support of children and families for many years. The BGCB's main facilities include the main "Clubhouse" in downtown Bellevue, the Lake Hills teen center (former Library) and the Hidden Valley Gymnasium. They also operate after school and summer programs in elementary schools, operate satellite club locations in several public housing sites and conduct programs at the City-owned South Bellevue and Crossroads Community Centers and operate the Lake Hills "Tech Center." BGCB provides significant youth program subsidies and scholarships annually.

Funding

The BGCB has proposed that they will fund the design, construction, maintenance and operation of the fieldhouse. BGCB believes that their capacity to raise the funds is limited to the cost of the facility, thus acquiring land is not feasible if the project is to move forward. If BGCB is unable to raise the funds privately, the project will not proceed.

LEGAL/REGULATORY ISSUES

1. **Restrictions on the use of property.** Site analysis will include review of any property restrictions in the Deed. Funding mechanisms to acquire and development a site will also be reviewed for any potential restrictions.
2. **Authority to enter into this Partnership.** The Revised Code of Washington (RCW) provides the authority for a city to lease "all or any part of a multi-purpose community facility" to any municipality, government agency, private corporation, or individual. The terms and conditions of any agreement are at the discretion of the City Council. RCW further authorizes cities to lease land to agencies or private parties and then "lease back" or contract for space to conduct recreational programs.
3. **Gift of Public Funds to Private Entities.** State law prohibits gifting of public funds to private entities "except for the necessary support of the poor and infirm." Thus, the City cannot simply provide property to the BGCB without consideration received by the public. The form and amount of consideration is at the discretion of the City Council, though compensation must comply with the legal requirements established by state law. If this concept moves forward, the City would need to appraise the property needed for the fieldhouse, including required setbacks and the use of parking, to use as a benchmark for discussion. The value of the public benefits must equal or exceed the appraised value.
4. **Land Use Regulations.** All site evaluation will include review of the City's Land Use Code.

PLANNING AND POLICY GUIDANCE

Several relevant planning goals and policies can help guide the discussion.

1. The **Parks & Open Space System Plan** provides that multi-use community recreation centers be equitably distributed throughout the city. This facility could provide a component of

community/public recreation that doesn't currently exist. The Plan also advocates the use of partnerships to efficiently satisfy the needs of the community, suggesting the establishment or expansion of partnerships with the School District and other service providers to supplement programs and facilities provided in City-owned facilities. And finally, the Plan advocates tracking community preference to provide a wide range of alternative sport and recreation programs and facilities to meet diverse and changing needs of the community.

2. The **Comprehensive Plan** provides relevant policy guidance regarding the delivery of community recreational services, as follows:
 - Equitably distribute a variety of parks, community centers and other indoor and outdoor recreation facilities throughout the city.
 - Develop partnerships with other public agencies and the private sector to provide parks, open space, and cultural and recreation facilities in the city.
 - Encourage privately funded recreational and cultural facilities throughout the city, especially in major employment centers.
 - Encourage the development of facilities for special purpose recreation.
 - Provide a variety of services and programs accessible to all throughout the city with special emphasis on serving those with limited opportunities, including low-income households, youth, individuals with disabilities and older adults.
 - Develop partnerships with not-for-profit organizations in planning, developing, and utilizing facilities.
 - Collaborate with school districts and private and non-profit providers to deliver a coordinated array of recreation, athletic instruction, arts, gathering spaces, and community services.
 - Promote partnerships with public and private service providers to meet the cultural, recreational, and social needs of the community.

COMPARATIVE AGREEMENTS

Several existing agreements provide similarities to the current proposal, though the most similar is our 2013 Hidden Valley Agreement with the BGCB (Item #4 below):

1. **Ground Lease Agreements with Kinderling Center and Youth Eastside Services (1983, 1985).** Under the terms of two 50-year, \$1/year ground leases, YES and the Kinderling Center leased specific building areas and constructed facilities in Crossroads Park to provide ongoing social services. Both agreements include provisions for shared parking within the park. Both agencies met the Constitutional definition of supporting the poor and infirm. Both agencies fully funded the cost of their facility, and ownership of the buildings reverts to the City upon expiration of the ground leases.
2. **Joint Operating Agreement (JOA) with the BGCB at the South Bellevue Community Center (2003).** Under the terms of the 30-year JOA, BGCB contributed \$1.5 million towards construction of the \$12 million South Bellevue Community Center. The City owns and maintains the facility. BGCB is the primary provider of programs and services for youth and

teens, while the City primarily provides pre-school, adult, and senior programs as well as specialized recreation, fitness and wellness classes and special activities in accordance with schedules developed jointly by the parties.

- 3. Memorandum of Understanding and Joint Use Agreement (JUA) with Pacific Science Center at Mercer Slough Environmental Education Center (2004).** The City and PSC jointly obtained funding to construct MSEEC facilities through public and private sources. The City funded approximately \$5.5 million of the \$12 million project cost. Under the terms of the 20-year JUA, the City owns and manages all land and buildings. PSC has exclusive use of two buildings to conduct environmental education programs that complement City programs.
- 4. Ground Lease, Joint Development and Joint Operating Agreement with the BGCB at Hidden Valley Park for the construction and use of a gymnasium (2013).** The BGCB identified the need for additional gymnasium facilities and worked with the City to identify an appropriate location. The City provided a 50-year lease that allowed the BGCB to construct and operate a gymnasium in Hidden Valley Park. Cost of the gym was approximately \$6.5 million, and ownership reverts to the City upon expiration of the lease. In return, the BGCB split the cost to complete park improvements (\$5 million total cost, \$2.5 million BGCB share) and provides the City a minimum of 70-hours/week to utilize the gymnasium for community recreational programs at no cost.
- 5. Agreement with Seattle University regarding the use and improvements to Bannerwood Park (2014).** In return for Seattle University funding the installation of artificial turf on the infield of the Bannerwood Park baseball field, the City provides guaranteed use of the field for games and practices for their baseball team during times that do not conflict with the community use of the field.
- 6. Agreement with the BGCB for the City's priority use of space in the BGCB Downtown Clubhouse (2015).** The City provided \$1.5 million to the BGCB toward construction of their new approximate \$9 million Clubhouse facility in downtown Bellevue. In return, the City receives a minimum of 100 hours/week of priority use in the facility to run community recreational programs for 40-years.
- 7. Eastside Heritage Center.** Eastside Heritage Center provides in-kind services, payment of utilities, and routine maintenance to the City in exchange for use of City-owned McDowell House and Winters House (when it re-opens). The Center provides historic and heritage programming within the community and at Winters House. They coordinate and provide volunteers to enhance events such as Arbor Day/Earth Day, Natural Resources Week, Magic Season and others. EHC staff also consult with Parks staff on historical research and content for park interpretive signage and displays.

SITE REVIEW

The BGCB's target service area for the fieldhouse is east Bellevue, though broadly defined as east of I-405 and north of I-90. Locating a facility of this size, given its parking requirements and the City's well-developed park system, is extremely challenging. Because of the estimated size of the facility,

we initially focused on our inventory of community parks, as they are generally larger and contain more generous residential buffers. To reduce the impacts/footprint of the facility, we then looked at community parks with the potential for shared parking. The following locations emerged: Robinswood, Airfield, Marymoor, Wilburton Hill, North Bellevue Community Center and Bannerwood.

Several factors should be considered when identifying a possible final fieldhouse location:

- The original Master Plan
- Compatibility with existing park amenities including impacts to the parks natural features.
- Proximity to the parking lot and the possibility for shared parking.
- The presence of adequate residential buffers is always a consideration in locating park facilities, but especially important when locating large buildings.
- Constructability. Can the facility be built without excessive costs to accommodate unusual building conditions or required mitigation of impacts?
- Timing. Can the facility be constructed in a reasonable time frame?

COUNCIL DIRECTION

The City Council was briefed at their October 1st Council meeting regarding the Boys & Girls Club of Bellevue's (BGCB) proposal to develop a fieldhouse in the City of Bellevue. They have directed the Parks & Community Services Board to establish a process to review the proposal including site analysis, and staff is to prepare a management brief outlining this process for Council. The board has been directed to engage the public, provide opportunities for feedback, and deliver a recommendation to the Council regarding this proposal.

NEXT STEPS



FEEDBACK REQUESTED

The Parks & Community Services Board will be provided an update on the Wilburton Segment of the Eastside Rail Corridor, which runs from I-90 north through Bellevue to 108th Avenue NE. The Board will have the opportunity to provide feedback on the trail design concepts presented during the meeting and at a public open house, scheduled for 5:30 to 7:30 on October 9 at City Hall.

BACKGROUND

King County is leading the planning and development of a multiuse pedestrian and bicycle trail along the Eastside Rail Corridor (ERC). The ERC is a 42-mile rail line that was operated by the Burlington Northern Santa Fe Railway Company until 2008. The line extends from Renton north into Snohomish County, passing through Bellevue, Kirkland, and Woodinville, and extending via a parallel spur to Redmond.

The first two segments of trail in Bellevue opened for use in early 2018: trail segments now extend north from the Spring District to Kirkland and south from Newcastle Beach Park to Renton. In addition, King County is working closely with WSDOT, who will construct a trail bridge over I-405 near Mercer Slough as part of its upcoming Renton to Bellevue Express Toll Lanes Project. WSDOT will provide connectivity for bicycles and pedestrians by constructing the bridge at the location of the former Wilburton train tunnel and will additionally construct 2.5 miles of paved trail in the ERC between Coal Creek Parkway and Ripley Lane. Design and development for the remaining stretch of trail through Bellevue is currently underway. King County is hosting an open house at Bellevue City Hall on October 9 to gather public feedback on concepts for the remaining sections, known as the Wilburton Segment.

King County owns most of the corridor through Bellevue and holds a continuous trail easement along segments that are owned by others. Sound Transit owns a 1.1-mile segment of the corridor in Bellevue and holds an easement for transit along other segments; and Puget Sound Energy also holds an easement for utility use along the corridor. The corridor is "rail-banked," which means that it must be preserved as a continuous route and there is the potential for reactivation of the corridor for freight rail under certain circumstances. Since 2013, the ERC owners have worked together through the Eastside

Rail Corridor Regional Advisory Council (RAC) to maintain a collaborative, regional planning process for the ERC. In 2017, the RAC structure was revised to include adjacent non-owner jurisdictions (Bellevue and Renton) and the Eastside Greenway Alliance (a coalition of seven community non-profit organizations). Although Bellevue is not an ERC owner, it is the permitting authority for the segment passing through the city's limits. The city is also working to advance the ERC trail by supporting design and development of key trail crossings and connecting links into the corridor.

PARKS CIP PROJECT STATUS REPORT September 2018

Aquatic Center Study

No Change. Staff has reviewed ten proposals and have developed a short list of four teams to interview in order to select a consulting team to explore the potential scale and scope of an aquatic facility, estimated capital and operating costs, site feasibility, and potential partnerships. The initial feasibility study done in 2009 will be updated to serve as a foundation for this new work. We anticipate the feasibility work to begin this fall.

Bannerwood Park

Staff is working with representatives of Seattle University to provide additional upgrades to the Bannerwood baseball facility. SU would like to install a roof over the existing batting cages and to construct a small multi-use/clubhouse building behind one of the dugouts, all at the cost of SU. We are currently working to amend our current agreements with SU to facilitate these improvements.

2019-25 CIP Budget

The Park Board approved a letter to the City Council endorsing the 2019-25 CIP budget projects. The Leadership Team delivered a recommendation to the City Manager in August. The requests include continued funding for the Renovation Program, Park & Open Space Acquisition, and Park Planning; neighborhood park development in Bridle Trails and Newport Hills; construction at Airfield Park; planning and construction of future phases of Meydenbauer Bay; supplemental funding for Downtown Park's NE Gateway; and initial funding for Bel-Red parks and streams.

Downtown Park – NE Gateway

No Change. The Park Board was briefed July 10th on the site conditions, strategies, and challenges facing the Gateway project. The four options presented included strategies for the placement of the Union High Arch, interaction with the adjacent commercial properties, integration of public art, water feature options, gateway plaza, and connections to the DTP. We are now developing a preferred plan based on the comments received and hope to present a preferred site plan to the Board at a joint Park Board/Arts Commission meeting this fall. We met with the artist in August and will be refining the initial concepts for review by the Arts Commission.

Meydenbauer Bay Phase 1 Park Development

Construction is now 80% complete, with expected completion at the end of 2018. The beach house exterior and interior work is near completion, final finishes are underway. The swimming platform and the floating pier sections are now installed. Final beach construction and shoreline restoration is underway. Concrete retaining walls are now complete, and the rock retaining wall and terrace work is also nearing completing. Pedestrian pathways will be paved in the next several weeks. Right-of-way work along 99th Ave. and Lake Washington Blvd (LWB) is complete except for driveway and parking lot approaches, which will be complete in September. A pedestrian crossing at LWB and 99th St. is being installed. Irrigation and landscape improvements will continue through November. The Whaling Building renovation is underway. We are developing a parking plan to address the busy summer season, as we expect that parking will be challenging during hot summer days.

Water and sewer to the park has been completed and final electrical work is in-process. Some planting/restoration work may continue next spring depending on weather and light rail construction. Staff continues to work with the adjacent neighbors to address property encroachment issues and the new boundary fence. The last (3rd) letter prior to fence installation work has been sent to neighbors notifying them that fence removal and replacement will occur this fall.

INTRODUCTION

The City of Bellevue’s Well K.E.P.T. (Kids Environmental Project Training) program has completed another successful summer serving the Bellevue community. For 31 years, Bellevue Parks & Community Services has engaged youth and invested in our city’s future by providing valuable employment opportunities to Bellevue youth through Well K.E.P.T.

The Well K.E.P.T. program is a summer youth employment opportunity offered through the Bellevue Parks’ Natural Resource Division. The program is designed to provide Bellevue youth with education, job skills, and career development training in the field of park resource management. The work focuses on parkland restoration and maintenance. This summer, typical projects included forest enhancement, trail construction, and wetland restoration. Well K.E.P.T. combines on-the-job work experience with environmental education and career development to instill strong self-esteem, good work habits, and sound environmental ethics. Trainees developed and strengthened technical experience related to natural resource best management practices and trail construction techniques.

2018 PROJECTS & ACCOMPLISHMENTS

Bellevue Community Partner Projects: *Community Partner projects strengthen community connections with local ecosystems and C.O.B. services. Through involvement with these projects, trainees gained a deeper understanding and appreciation for sustainable urban agriculture and equitable access to fresh foods while supporting C.O.B.'s facilitative role.*

- **Mercer Slough Nature Park:** Harvested **18 gallons** of blueberries for enriched community access.
- **Farmer Frog:** Removed and composted various herbaceous weeds from Farmer Frog plots.

Noxious Plant Removal Projects: *Noxious plant removal projects help develop an understanding of plant physiology, introduce techniques of plant identification, and teach the importance of vegetative management for maintaining healthy forest and wetland ecosystems in urban environments.*

- **Weowna Park:** Removed English Ivy from **76 native trees** in one day.
- **Viewpoint Park:** Removed ground English Ivy from an area of **10,200 ft²**.
- **Wilburton Hill Park:** Removed English Ivy from **129 native trees**.
- **SE 6th Street:** Removed English Ivy from **77 native trees**.
- **Horizon Highlands:** Removed ground English Ivy from an area of **3,500 ft²**.
- **Hillaire Park:** Removed Himalayan Blackberry from an area of **14,100 ft²**.
- **Mercer Slough Nature Park:** Removed **720 gallons** of Purple Loosestrife (Class A noxious weed) and **120 gallons** of Bittersweet Nightshade.

Trail Construction Projects: *Trail construction projects provide trainees a hands-on opportunity to apply trail construction techniques while developing proficient skills with tool usage and care. Through this experience, trainees gain a deeper understanding of the pivotal role integrated trails have in the holistic management of Bellevue’s green space system. Trainees developed a deeper understanding of Bellevue’s natural environment while strengthening environmental stewardship.*

- **Lower Coal Creek:** Removed and replaced **15 retaining wall structures** between 8’ and 64’ in length. Manually transported **2.25 tons** of new structure material to remote locations including: **61 poles** and **115 posts**. Redefined and widened **2,640 ft** of trail surface using **14 yd³** of gravel and **7 yd³** of mulch. Resurfaced **263 ft** of trail using **10.6 yd³** of mulch at Washout Way.



We've enclosed two color print documents in support of our email sent to the entire Parks & Community Services Board in preparation for your Regular Monthly meeting tomorrow. Please share these documents with others in attendance; plus the old, outdated Master Plan that was to be revised and completed during 2012.

Mary and I trust that you will find our photo-shoots intriguing, enlightening and informational, especially linkages to the enclosed Parks Policies that apply. We know that probably none of this current Board recalls or remembers the history or years of community efforts by residents and Retirement Centers nearby to "KEEP ASHWOOD PARK GREEN". But none of that has made any difference so far.

Strange result lacking meaningful actions; and many excuses but no follow-thru. However, the Parking Lot was upgraded with many trees, irrigation, re-paving, sidewalk improvements, plus surrounding shrubs or grasses extending along the 112th Street sidewalk.
