1. **CALL TO ORDER:**

The meeting was called to order by Chair Van Hollebeke at 6:10 p.m.

2. **APPROVAL OF AGENDA:**

Motion by Boardmember Heath and second by Boardmember Kumar to approve the meeting agenda as presented. Motion carried unanimously (5-0).

3. **APPROVAL OF MINUTES:**

Motion by Boardmember Heath and second by Vice-Chair Synn to approve the June 13, 2017 Parks & Community Services Board Meeting Minutes as presented.

Motion by Vice-Chair Synn and second by Boardmember Kumar to amend page 6 of the meeting minutes, first paragraph, to read:

After Chair Heath became the Parks Board Chair, he ~~attended a~~ reviewed the Planning Commission meeting minutes and noted that the. ~~At that meeting, the~~ Planning Commission Chair asked at one of the Planning Commission meetings ~~Chair Heath~~ why the Parks Board was not involved with the Comprehensive Plan amendments.

Motion carried unanimously (5-0) to approve the amendment to the main motion.

At the question, motion carried unanimously (5-0) to approve the meeting minutes as amended.

4. **ORAL COMMUNICATIONS/PUBLIC COMMENTS:**

None.

5. **COMMUNICATIONS FROM CITY COUNCIL, COMMUNITY COUNCIL, BOARDS AND COMMISSIONS:**

None.

6. **DIRECTOR'S REPORT:**

- Follow-up on Oral Communications/Public Comments from prior meetings

Mr. Foran expressed his appreciation to staff, in particular Glenn Kost, Ken Kroeger and Pam Fehrman, for a job well done with the Downtown Park project and Grand Opening. The Grand Opening was well attended, and the park was enjoyed by approximately 70,000 people during the Bellevue Family 4th of July Celebration. Special recognition was also extended to the Bellevue Downtown Association, as well as Bellevue Police and Fire for their assistance.

7. **CHAIR COMMUNICATION & DISCUSSION:**

A. **Next Quarter's Agenda Items**

Chair Van Hollebeke requested that Boardmembers discuss the current status of the Bylaws as well as the Parks Board Liaison relationships with other Boards/Commissions later in the meeting agenda.

Chair Van Hollebeke attended the Downtown Park Grand Opening and commended staff for completing the long-held vision for the park. He also commended the Bellevue Rotary for their fundraising efforts. Chair Van Hollebeke has heard concerns from the Old Bellevue Merchants Association that parking around Downtown Park continues to be a challenge.

8. **BOARD COMMUNICATIONS:**

Boardmember Deng enjoyed the Downtown Park Grand Opening and commended staff for their hard work with this project. She also appreciates the improved lighting at Downtown Park.

Boardmember Kumar and Vice-Chair Synn both attended the Downtown Park Grand Opening as well as the Strawberry Festival.

9. **BOARDMEMBER COMMITTEE/LIAISON REPORTS:**

A. Wilburton Citizen Advisory Committee

Boardmember Kumar reported that the Wilburton CAC is currently working on ideas for a tactical urbanism for the Wilburton area. Chair Van Hollebeke suggested that food trucks, similar to the ones at the Ashwood Park food truck event, be considered.

Boardmember Kumar also reported that the Wilburton CAC evaluated some bicycle/pedestrian mock-ups of lanes and potential permeable surfaces. The goal is to make the area pedestrian friendly, while accommodating traffic.

Next steps for the Wilburton CAC include working on the Draft Environmental Impact Statement.

Chair Van Hollebeke questioned if there is an opportunity for the Parks Board to contribute comments to the Wilburton CAC. Boardmember Kumar encouraged Boardmembers to review the Wilburton CAC meeting minutes and provide comments at any time. She clarified that the Committee is currently in the learning/visualizing stage of the process. Chair Van Hollebeke requested that Boardmember Kumar speak with the Wilburton CAC to determine if there is an opportunity for the Parks Board to provide direct feedback. Boardmember Kumar will speak with the Wilburton CAC regarding Chair Van Hollebeke's request. In addition, he noted that there is currently an opportunity to comment on the Grand Connection Sequence One Plan.

B. Planning Commission Follow-Up

No report.

10. **DISCUSSION/ACTION ITEMS**

A. Thank You for Outgoing Chair Stuart Heath

On behalf of the Board, Chair Van Hollebeke thanked former Chair Heath for his Board leadership. Boardmember Heath was also presented with a token of appreciation.

B. Grand Connection Briefing

Mr. Calvert provided an overview of the Wilburton-Grand Connection. Mr. Smith clarified that there is currently an opportunity to provide the Wilburton CAC feedback.

Mr. Calvert noted that the Grand Connection has been broken into two visioning phases: Sequence One and Sequence Two. He summarized the events that have occurred thus far. When discussing the art and culture of the Grand Connection area, Vice-Chair Synn would like the term “cultural inclusion” utilized rather than “cultural diversity.” Mr. Foran added that the term “diversity” should be utilized to open more creativity and inclusion. Other Boardmembers agreed with this suggestion.

Mr. Calvert noted that the Draft Framework Plan for the Grand Connection Sequence One of the visioning process has been released. This phase of work addresses the segment between Meydenbauer Bay and the Civic Center District. The Draft Framework Plan includes the following chapters:

- Executive Summary
- Chapter 1 - Introduction
- Chapter 2 - Public Engagement
- Chapter 3 - The Route
- Chapter 4 - Creating a Distinct Identity
- Chapter 5 - Cohesive Design Strategies
- Chapter 6 - Art and Culture
- Chapter 7 - Connectivity and Mobility
- Chapter 8 - Re-Imagining Public Spaces
- Chapter 9 - Interstate 405 Crossing
- Chapter 10 - Opportunities for Programming
- Chapter 11 - Implementation and Next Steps

Vice-Chair Synn requested that the term “accessibility” be included in some of the documents, not only for mobility but also for services offered by Bellevue. He added that this may fall under Chapter 7 – Connectivity and Mobility.

Boardmember Heath suggested that the term “public space” be changed to “parks and open space” within the Draft Framework Plan. Mr. Calvert explained that the term “public space” is used because it encompasses many different spaces (e.g., plazas, open space, parks, green space, etc.).

Chair Van Hollebeke requested clarification regarding the relationship between the Grand Connection and Parks Department. In particular, he wondered if the project is a Parks project or a multi-departmental project. In addition, Chair Van Hollebeke asked if the Grand Connection is tied to the Parks vision (i.e., pearls on a string connecting all of the parks). Mr. Calvert noted that the Draft Framework Plan is currently in the preliminary visioning stage and is multi-departmental. He added that the “pearls on a string” reference is utilized quite a bit in planning to improve connectivity. Mr. Calvert clarified that the Draft Framework Plan provides

background information, recommendations, art and culture elements, and next steps. He also noted that the Wilburton CAC does not work on the Grand Connection.

Mr. Calvert summarized the timeline for the Draft Framework Plan. If the Parks Board would like to provide feedback/comments, he suggested that this be done before October, when it will be presented to City Council.

Boardmember Heath asked how community services fits into the Grand Connection or Wilburton CAC. Mr. Calvert clarified that community services are more aligned with the Wilburton area. Mr. Smith added that accessibility is part of community services (i.e., interactive play, experiential learning, recreation, culture, educational, etc.).

Chair Van Hollebeke noted that there could be an opportunity for wayfinding throughout Wilburton-Grand Connection. He also suggested that there is room for improvement to the wayfinding near and around Compass Plaza.

Mr. Calvert discussed Sequence Two of the Draft Framework Plan for the Grand Connection, which includes the Interstate 405 Crossing. Visioning goals for this crossing have been established along with various crossing alternatives. An online open house will be conducted to gather community feedback about the various crossing alternatives.

Mr. Calvert showed a map of the Wilburton Commercial Area. The Wilburton CAC is evaluating the land use, transportation, urban design, character, implementation strategies, and other elements for this area. Mr. Calvert summarized some of the messages received from the Wilburton CAC's research and showed ways that open/green/public space could be deployed (i.e., Grand Connection, civic center, neighborhood green space, ERC linear park, natural network). Mr. Calvert also summarized some of the density and height elements that are being considered. There is also a community inspired Simon project that is being researched as an interactive game.

Boardmember Heath likes the forward thinking, outreach and community involvement for the Draft Framework Plan. He would like to have a chapter included for "parks and open space" and "community services." Boardmember Heath stressed the importance of the Parks Board proactively evaluating the Draft Framework Plan. Chair Van Hollebeke concurred with Boardmember Heath. He would also like the Parks Board to have an opportunity to provide feedback, particularly during some of the design process. Mr. Calvert clarified that it is difficult for the Parks Board to be involved in renderings at such an early stage in the process. It will be most valuable for the Parks Board to provide input during the comment period.

Chair Van Hollebeke suggested that a parks motif be included throughout the Draft Framework Plan. He also suggested that Boardmembers review the plans in detail, particularly areas pertaining to community services, so feedback can be provided. Boardmember Kumar added that it would be valuable for Boardmembers to provide feedback on the different alternatives and whether or not they are achieving the Parks & Community Services goals.

Vice-Chair Synn expressed concern that the art in the Grand Connection will be seen as a physical asset versus artistic element. He also suggested that the term “community” be included throughout Mr. Calvert’s presentation. Lastly, Vice-Chair Synn offered suggestions on how to structure the Simon game.

Break—7:45-7:50 p.m.

C. Board Visioning and Planning

Looking back, Chair Van Hollebeke explained that the visioning and planning process was created to ensure that every Boardmember is heard and engaged in board work; to increase meaningfulness and transparency of the Board process; and to ensure progress on the shared priorities. For future planning, Chair Van Hollebeke suggested that the Board begin formulating a vision to serve as the “north star” and determine priorities to guide the next one-two years of Board work.

The following is a list of questions and responses for a survey that Chair Van Hollebeke conducted with Boardmembers:

Fifty years from now, you are touring the Bellevue Parks & Community Services system—what would you want to see? What are the three most important aspects of Bellevue Parks & Community Services?

Chair Van Hollebeke:

- Want/vision a park system to inspire people without overwhelming them. Something that is new and exciting and connected to nature.
- The vision should be centered around community involvement.
- The vision should bring Bellevue to a whole that is greater than the sum of its parts.

Boardmember Deng:

- Signs with other languages (diversity).
- Community involvement—ask everyone to have an ownership in building and maintaining the parks system.
- Recognize everyone and have a shared goal to make Bellevue a better place.

Boardmember Kumar:

- Wayfinding signs and kiosks that talk in multiple languages in and around Bellevue.
- A park on Lake Sammamish that connects to the ERC and then Meydenbauer.
- A string of pearls (i.e., trails) that circles the city that is multimodal.
- Conditions: community and money

Boardmember Heath:

- Bel-Red Commons.
- Citizen engagement and active lobbying presence for parks.
- Would like the city's highest priority to be funding for parks.
- Would like community services performed in partnership with non-profits (i.e., citizen engagement/involvement).
- How: 1) need leaders to rally the community for parks (citizens); 2) need political will; 3) need funding.

Vice-Chair Synn:

- Vision Parks & Community Services integrated with the city's identity (like Central Park is New York's identity).
- Community interaction.
- Can always utilize/access parks—always on.
- How: funding, education, advocacy, partnerships.

Motion by Boardmember Heath and second by Boardmember Deng to extend the meeting until 8:40 p.m. Motion carried unanimously (5-0).

What about Parks & Community Services do you care the most? Why did you join the Parks Board? If there is one thing you'd like to see accomplished during your Parks Board tenure, what would it be?

Boardmember Heath:

- A mechanism for community involvement, including liaisons to other Boards/Commissions, as well as education.
- Be educated on parks standards, funding needs, and funding alternatives.
- Help Council integrate with the Parks Board, as well as other Boards and Commissions—need to work together.

Boardmember Kumar:

- Understand how Parks & Community Services is managed by hearing from staff and participating in community events (i.e., education).
- Secure funding to complete parks (e.g., Airfield Park, park on Lake Sammamish, Newport Hills Park).
- Begin planning for interactive kiosks and wayfinding.

Vice-Chair Synn:

- Define and agree to Parks & Community Services Board strategy—work with the community, Council, and other Boards/Commissions.
- Clear sources of funding.
- Advocacy program (i.e., Boards, community, etc.).

Boardmember Deng:

- Alternative funding.
- Integrate diversity.
- Parks & Community Services education/neighborhood identified partnerships.

Chair Van Hollebeke:

- Alternative funding.
- Education/advocacy.
- Leverage existing and/or creating new partnerships.

Chair Van Hollebeke identified the following themes from the discussions above:

- Alternative funding.
- Education/partnerships.
- Advocacy.

Motion by Boardmember Kumar and second by Boardmember Heath to extend the meeting until 8:45 p.m. Motion carried unanimously (5-0).

This year, the Board received two presentations on the Grand Connection, in January and July. This City Council Priority project will create a defined and distinctive connection from Meydenbauer Bay Park, through Downtown, over I-405, through Wilburton to the Eastside Rail Corridor. As presented in July, a draft Framework Plan is open for public comment now. The plan focuses on the western portion of the Grand Connection, between Meydenbauer Bay Park and City Hall.

Following the July presentation, the Board expressed a desire to submit comments on the draft Framework Plan. Included in the packet is the revised Parks & Community Services Bylaws draft. I met with Charmaine Arredondo (Assistant Director, City Clerk's Office) and Jerome Roache (Assistant City Attorney) about the concerns expressed by the board and particularly Mark and Eric.

We changed the name to Parks & Community Services Board in the initial paragraph. Thereafter in accordance with city standards, we're simply referred to as the Board.

We do need to keep our bylaws consistent with the city standards as set by the City Clerk and the latest revised Robert's Rules of Order. For instance, if we all agree and vote on it, we can change our agenda a bit but we must always do the traditional approval of the minutes and agenda at the beginning of the meetings.

The City Council suggests that all boards and commissions to adhere to the new guidelines for oral communications – no more than 30 minutes total and three minutes per person – no longer the five minutes for a group. The goal is to be standardized and consistent.

We clarified the calendar year confusion about missing meetings and also things such as board elections.

If the Board has no further changes to the Bylaws, Charmaine and Jerome will review them once again. The Board will then be able to vote to approve the Bylaws in May.

PARKS & COMMUNITY SERVICES BOARD BYLAWS

These Bylaws constitute the official rules of procedure for the Parks and Community Services Board (hereinafter referred to as the Board). Where rules of procedure are not addressed in these Bylaws, the Board shall be governed by the City Council's adopted Rules (Resolution No. 8928) and/or by *Robert's Rules of Order, Newly Revised*.

ARTICLE I - Scope of Authority/Responsibility

The members of the Board accept the responsibility of the office and declare their intention to execute the duties defined under the State law and Bellevue City Code to the best of their ability and to respect and observe the requirements established by the Bellevue City Council.

The authority of the Board is limited to those specific functions set forth in the Bellevue City Code. The purpose of the Board is advisory to the City Council.

The Board shall have no authority or responsibility relating to the following activities:

- A. The Board or its individual members shall not speak for or advocate on behalf of the City or Board, or act in a manner that may be construed as representing the City, unless specifically authorized to do so by the City Council.
- B. The Board or its individual members have no supervisory authority and shall not direct administrative operations, maintenance, or hiring of consultants and other independent contractors.
- C. The Board shall not participate in regional issues not specifically assigned to the Board by the City Council.

A member of the Board is not authorized to speak for the Board unless the Board has expressly authorized the member's communication.

An individual member is free to voice a position, oral or written, on any issue after making it clear that the member is not speaking as a representative of the City or as a member of the Board.

ARTICLE II - Membership and Organization of the Board

A. Membership.

1. Each person at time of nomination and continuing uninterrupted thereafter while serving on the Board shall be a resident of the City of Bellevue. If residency is broken at any point, the Council Liaison assigned to the Board shall recommend to the City Council a new Board member for appointment. (See Resolution 8928, Section 5C for full process).
2. Each person to be appointed shall be nominated by the Council Liaison for a specific, numbered position on the Board.

3. Appointees shall commence service after confirmation by the City Council and the effective date of the previous member's resignation or expiration of the existing term for the position, as applicable.
 4. Each confirmation motion by the Council shall include the ending date and term for the position to which the member is appointed and that information shall be entered into the Council meeting minutes and maintained in the Board's records by the Deputy City Clerk.
- B. Election of Officers. The Board shall elect a Chair and Vice-Chair, and any other officers the Board deems necessary, for a term of one year at their first regular meeting in June of each year, or as soon thereafter as feasible based on seating of newly-appointed members.
- The election process shall be in accordance with *Robert's Rules of Order Newly Revised*.
- In the event of the resignation of the Chair or Vice-Chair, the Board shall expeditiously elect a new officer to fill the vacancy for the remainder of the existing term.
- In the absence of the Chair and Vice-Chair, a Chair pro tem shall be elected informally by the members present to conduct the meeting.
- C. Committees. The Chair, with the concurrence of the Board, may appoint standing committees or special committees of the Board and assign one or more members to such committees.
- D. Quorum. At all meetings of the Board, quorum shall consist of a majority of the members.
- E. Ex officio members. The Council may approve the appointment of an ex officio member to the Board. Ex officio members are authorized to sit at the table and participate in discussions, but are non-voting members.
- F. Resignation. A member may resign by giving written notice to the City Clerk and the Chair of the Board.
- G. Removal from office. Members of the Board may be removed at any time by the Mayor, upon approval of a majority of the Council for neglect of duty, conflict of interest, unexcused absence from three consecutive regular meetings of the Board, or for any reason deemed sufficient by the majority of the Council. The decision of the Council shall be final and there shall be no appeal.
- H. Vacancies. Vacancies shall be reported immediately to the City Clerk.
- Vacancies occurring for reasons other than the expiration of a term shall be filled for the unexpired portion of the term. The appointment is made by the Mayor upon approval of a majority of the Council.
- I. Staffing. The Parks and Community Services Department Director shall assign staff support to the Board.

ARTICLE III - Duties

- A. Presiding Officer. The Chair shall be the presiding officer of the Board. In the temporary absence of the Chair, the Vice-Chair shall perform the duties and responsibilities of the Chair.

It shall be the Presiding Officer's duty to see that the transaction of Board business is in accord with these Bylaws.

- B. Presiding Officer Duties. It shall be the duty of the Presiding Officer to:
1. Call the meeting to order.
 2. Keep the meeting to its order of business.
 3. Control the discussion in an orderly manner.
 - a. Introduce the agenda topic, provide for staff presentation and questions from the Board, and call for discussion among the Board members.
 - b. Give every Board member who wishes an opportunity to speak.
 - c. Permit audience participation at the appropriate times.
 - d. Require all speakers to speak to the question and to observe the rules of order.
 - e. Give pro and con speakers opportunities to speak to a question when practicable.
 - f. Guide the Board in providing direction to staff and making recommendations to the City Council.
 4. State each motion before it is discussed and before it is voted upon.
 5. Put motions to a vote and announce the outcome or summarize consensus direction achieved by the Board.
 6. Decide all questions of order, subject to the right of appeal to the Board by any member.

The Presiding Officer may at his or her discretion call the Vice-Chair or any member to take the Chair so the Presiding Officer may make a motion.

- C. Board Staff Duties. The Board staff, or an authorized designee, shall attend all meetings of the Board. The Board staff shall:
- a. Provide for noticing of special meetings or changed locations of meetings;
 - b. Post agendas and Board packet materials for each meeting;
 - c. Record and retain, by electronic means, each meeting for the official record;
 - d. Provide for timely preparation of summary minutes of all Board meetings;
 - e. Maintain the Board's official records;
 - f. Manage correspondence on behalf of the Board.

ARTICLE IV - Council Liaison

- A. The Mayor, with the concurrence of Council, shall appoint a Councilmember to serve as Liaison to the Board.
- B. The Council shall identify roles and responsibilities for Liaisons to the Council's appointed Boards and Commissions.

ARTICLE V - Meetings

Public notice of meetings or of hearings before the Board shall be provided as required by law. Noticing of special meetings and public hearings is provided by the Deputy City Clerk.

- A. Regular meetings. The regular meetings of the Board shall be held at 6:00 pm on the second Tuesday of each month; unless there is critical or time-sensitive work, the Board may recess for either the month of August or December.

Regular or continued meetings that fall on a holiday shall be rescheduled by the Board.

- B. Special meetings. Special meetings may be held by the Board subject to notice requirements prescribed in state law. The notice for special meetings shall state the subjects to be considered, and no subjects other than those specified in the notice shall be considered.

Electronic mail shall be considered written notice to members for purposes of this rule.

- C. Meeting place. Meetings of the Board shall be held at Bellevue City Hall unless otherwise noticed.

- D. Open Public Meetings. No legal action may be taken by the Board except in a public meeting. "Action" is defined as the transaction of official business, but is not limited to receipt of public testimony, deliberations, discussions, considerations, reviews, evaluations, and final actions.

All meetings of the Board shall be open to the public; provided, the Board may hold Executive Sessions as permitted by law (RCWs 42.30.110 and 43.30.140).

Minutes will be prepared for all regular and special meetings and presented as soon as practicable for Board review and approval. Minutes will include all pertinent information, motions, decisions made, and actions and votes taken. Minutes are not required to be taken at an Executive Session (RCW 42.32.030).

- E. Public Notice. Public notice of meetings or hearings before the Board shall be provided as required by law. Notice of special meetings will be delivered in writing by mail or electronic mail at least 24 hours in advance to Board members and to the City's newspaper of record and other media publications that have filed written requests of the City to be notified. The notice will specify the time and place of the special meeting and the business to be transacted.

- F. Attendance. Attendance at regular and special meetings is expected of all Board members.

Any member anticipating absence from an official meeting should notify the Board staff in advance.

Unexcused absences from three consecutive regular meetings shall be reported to the City Council for appropriate action as prescribed by Bellevue City Code, Section 3.62.010.

- G. Remote participation. A member not able to be physically present for a meeting may participate remotely using approved teleconferencing equipment. Remote participation must be approved in advance, by majority vote of the Board, either at an earlier Board meeting or before joining a current meeting. A member may participate remotely no more than four times per calendar year, unless absent for medical reasons, and only two members may participate remotely during any one Board meeting. Such remote participation will be considered attendance at the meeting and shall be counted toward determination of a quorum.

- H. Recess. The Board may, by a majority vote or consensus, recess for a short break. The proposal to recess may set a time limit or run until the Chair calls the meeting back to order.

- I. Continuation. The continuation of a meeting shall be to a definite time and place and approved by majority vote.

- J. Adjournment. Regular meetings of the Board shall adjourn at 8:30 pm. The adjournment time may be extended to a later time certain upon approval of a motion carried by a majority of Board members.

At the conclusion of the agenda, after calling for any additional business, the Chair may declare the meeting adjourned.

ARTICLE VI - Order of Business/Agenda

- A. Preparation of meeting agendas will be the duty of the Board staff in coordination with the Chair.
- B. Copies of the agenda will be available to all Board members at least two days prior to a regular meeting and 24 hours in advance of special meetings.
- C. The agenda will indicate whether formal action is intended to be taken by the Board on a particular matter.
- D. The order of business for each regular meeting shall be as follows:
 - 1. Call to Order and Roll Call
 - 2. Approval of the Agenda
 - 3. Approval of Minutes
 - 4. Oral and Written Communications
 - 5. City Council Communication
 - 6. Director's Report
 - 7. Board Communication
 - 8. Chair Communication & Discussion
 - 9. Discussion / Action Items
 - 10. Board Member Committee / Liaison Reports
 - 11. New Business
 - 12. Other Communication
 - 13. Information
 - 14. Oral and Written Communications
 - 15. Adjournment
- E. The printed agenda of a regular meeting may be modified, supplemented or revised by a majority affirmative vote of the Board members present.
- F. A topic on the agenda may be continued to subsequent meetings when it is apparent that one meeting will not be sufficient to complete the scheduled business.
- G. The order of business does not apply to Special Meetings.

ARTICLE VII - Public Comment

- A. Timing of Communications. The Board shall not take public comment at regular meetings except for that given at a public hearing or at Oral and Written Communications. Written comments may be submitted to the Board staff in advance of the meeting.
- B. Addressing the Chair. Speakers shall address all statements to the Chair. Board members may direct questions to speakers only with the Chair's permission.

C. Public hearings. The purpose of a public hearing is to gather information and opinions on a specific subject the Board is studying. The following rules shall be observed during any public hearing:

1. The Chair shall, at the opening of a public hearing, state the purpose of and process for the hearing and may request that staff provide an introductory staff report.
2. Persons wishing to speak shall sign in on the sign-in sheet provided and will be called to speak in the order in which they signed.
3. Speakers will be allowed three minutes in which to make their comments. Additional time will not be allowed unless the Chair or a majority of the Board determines to allow additional time.
4. Speakers are encouraged to indicate support for or opposition to previous comments rather than repeating prior testimony.
5. No specific time limitations are placed on the length of public hearings.
6. The Board may continue a hearing to a future date or close a hearing after everyone wishing to speak has spoken.
7. All written material provided before or during the hearing will be included in the hearing record.
8. The Chair may allow additional time for receipt of written comments when needed.

D. Oral Communications.

1. The time allowed for Oral Communications shall not exceed 30 minutes.
2. Persons wishing to speak shall sign in on the sign-in sheet provided and will be called to speak in the order in which they signed.
3. Speakers will be allowed to speak for three minutes. Additional time will not be allowed unless the Chair or a majority of the Board determines to allow additional time.
4. Suspension of these rules will require a majority vote of the Board members present.

E. Decorum. Persons participating in Board meetings are strongly encouraged to aid the Board in maintaining the decorum and orderly progression of the meeting agenda. Engaging in shouting, use of profanity or slurs against others, disruptive noise, or comments that are off-topic detract from the ability of the Board to conduct business. Where such conduct results in actual disruption of the meeting, the Chair may issue a verbal warning to the speaker and, if the behavior continues, have the speaker removed from the meeting room. Repeated disruption may result in the speaker being excluded from participating in public comment at one or more subsequent Board meetings. If the Chair issues an exclusion to any speaker, he or she shall inform the person of the basis for the exclusion and the term of the exclusion. The Chair shall also notify the speaker that if he or she desires to address the Board during the period of exclusion from public comment, he or she may submit written comments which will be received by the Board staff and provided to each of the Board members.

F. Timekeeping. The Board staff shall be the timekeeper.

ARTICLE VIII - Motions

- A. No motion shall be entertained or debated until seconded and announced by the Chair. The motion shall be recorded and, if desired by any member, read by the Clerk before it is debated. With the consent of the Board, a motion may be withdrawn at any time before action is taken on the motion.
- B. Motions shall be entertained in the order of precedence outlined in *Robert's Rules of Order Newly Revised*.

ARTICLE IX - Voting

- A. Action. Action may be taken by a majority of the members present when a quorum exists.
- B. Votes on Questions. Each member present or participating remotely shall vote on all questions put to the Board except on matters in which he or she has been disqualified for a conflict of interest or under the Appearance of Fairness doctrine. Such member shall disqualify himself or herself prior to any discussion of the matter, stating the reason for the disqualification unless there is a legal impediment to disclosure. The disqualified member will then leave the meeting room.

Voting shall be accomplished by voice or through a showing of hands. Secret balloting is prohibited. Proxy votes of members not present are not valid votes. All votes shall be recorded in the Summary Minutes.

- C. Tie Vote. The passage of a motion is defeated by a tie vote, provided that the question may be brought forward again at the request of any member at the same meeting or at the next meeting when any members who were absent or disqualified at the time of the tie vote are present.
- D. Failure to Vote. Any Board member who fails to vote without a valid disqualification shall be declared to have voted in the affirmative on the question.
- E. Six-month Time Limitation. Except as otherwise provided in these Bylaws, once a matter has been voted on and the time for reconsideration has passed with no action, the matter may not be taken up again for six months unless there is a showing of a substantial change of circumstances.
- F. Decisions. The Board shall act as a body in making its decisions and in announcing them. The Chair or the Chair's designee shall serve as the spokesperson for the Board in reporting decisions.

ARTICLE X - Conflict of Interest, Appearance of Fairness, and Legal Assistance

Board members are held to high ethical standards and shall at all times comply with the provisions of Chapter 3.92 of the Bellevue City Code, as they exist now or as amended in future.

Any member of the Board who, in his or her opinion, has an interest in any matter before the Board that would tend to prejudice his or her actions shall so publicly indicate and shall step down and refrain from voting and participating in any manner on the matter in question to avoid any possible conflict of interest or violation of the appearance of fairness.

When there is doubt concerning the legality of an issue, the City Attorney (or designee) may be called upon to advise members as to the legality of the proposed action. If necessary, a hearing or deliberation may be continued until legal matters can be clarified. Care must be taken in maintaining records of the proceedings when litigation is a possibility.

ARTICLE XI - Minutes

- A. Minutes are the official record of a meeting. Electronic recordings of meetings are retained at the City for six years and then forwarded to the Digital Archives for permanent retention.

Minutes should be sufficiently detailed to provide what was done, by whom, and why, in order to provide an accurate summary of the main points of the discussion. Minutes are written to provide a readable, concise record of lengthy meetings, and as such not every speaker's comments on every topic are included.

If a Board member wishes to ensure that a particular statement is included in the minutes, he or she should indicate, "For the record, I believe...." to signal the desire to have this comment included.

- B. Draft minutes presented for approval in the meeting packet may be amended if a legally sufficient reason to do so exists.

Once approved, that page of amended minutes will subsequently show the following wording next to the spot of the amendment: "Corrected - see minutes of _____."

ARTICLE XII - Compliance with Laws

All Board members shall comply with all federal, state, and local laws and ordinances, including but not limited to Chapter 49.60 RCW (Washington's Law Against Discrimination) and 42 U.S.C. 12101 et. seq. (ADA), BCC 3.92 (Code of Ethics), RCW 42.56 (Public Records Act), RCW 42.30 (Open Public Meetings Act), BCC 2.26 (Public Records) and the Civil Rights Act of 1964 (Public Law 88-352).

ARTICLE XIII - Communications

- A. Communications with Council. The Board shall provide at least quarterly communications to the Council, either at Reports of Boards and Commissions or in written form. Reports should highlight major activities, future work plans, changes in work plans, and request any policy direction needed from Council.
- B. Communications among Board members. To avoid possible violations of the Open Public Meetings Act, Board members shall refrain from back-and-forth exchange of information, viewpoints, positions, or other dialogue via email, telephone, or in person among a quorum of the membership about the business of the Board outside of a public meeting. Communications among less than a quorum that are then relayed by a participant to other members, who together constitute a quorum, are also prohibited.

ARTICLE XIV - Records

The term “public records” applies to any paper, correspondence, completed form, bound record book, photograph, film, audio or video recording, map drawing, machine-readable material, videostream, email, text message, or social media that has been created or received by any state or local government agency during the course of public business and legislative records described in RCW 40.14.100. The following requirements apply to the Board and its individual members:

- A. Public records are the property of the City and must be managed (preserved, stored, transferred, destroyed, etc.) according to the provisions of RCW 40.14.
- B. Tools are in place to manage all emails sent to the Board’s email account (parkboard@bellevuewa.gov) according to state law.
- C. Board members are responsible for including Board staff on all Board-related communications, including forwarding any emails sent to the member in his/her individual capacity to the parkboard@bellevuewa.gov address. Any hard copy records shall also be transferred to staff for long-term maintenance.
- D. Members may be required to produce emails or documents that relate to the activities or operations of the Board in response to a public disclosure request. Members may also be required to produce their personal notes taken at Board meetings that relate to the activities and deliberations of the Board. To the extent that those notes contain information that is purely personal or material that is exempt under the Public Disclosure Act, they may not need to be provided to the requestor.
- E. As required by WAC 44-14-04003(2) and the City’s Public Records Act Rules, the City must provide the fullest assistance in response to public disclosure requests. The City’s Public Records Officer and a representative of the City Attorney’s Office will review any documents that may be exempt from disclosure and will provide the necessary explanations of any exemptions to the requestor if access to particular records is denied. Courts may award monetary penalties should the City not respond fully or promptly.
- F. Board members are advised to establish a separate, clearly-named file within their personal email account and/or on the hard drive of their personal computer to which they file all materials relating to the Board.

ARTICLE XV - Compensation and Reimbursement of Expenses

Members of the Board shall serve without compensation. Members shall be reimbursed for authorized travel or other expenses incidental to that service, which are authorized by the City Manager or City Council. Members should seek pre-authorization for any proposed expense.

ARTICLE XVI - Amendments

These Bylaws may be amended, revised, or repealed by the entire Board at any regular meeting or any special meeting, provided that notice of such changes is included on the agenda and the

vote to change takes place at the next regular meeting. Amendments will not be valid unless two-thirds of the membership of the Board vote in favor of amending the Bylaws.

ARTICLE XVII - Validity

If any part or parts of these Bylaws are found to be invalid, that part or parts will not invalidate the remainder of the Bylaws.

PARKS CIP PROJECT STATUS REPORT August 2017

Congregation for the Homeless (CFH) Temporary Center

Phase 1 of the temporary homeless shelter at the City-owned Lincoln Center is complete, which provides space for CFH to program day services. CFH will now relocate its current day center to this new facility, freeing up the space to begin Phase 2 (the overnight facility), which is expected to start September 11. This work will extend into November, after which CFH operations will continue here until a permanent shelter is complete. Several BOMA (Building Owners and Managers Assn) contractors are volunteering time and equipment to help reduce project costs.

Downtown Park – Complete the Circle and Rotary Inspiration Playground Expansion

The DTP projects opened to the public on June 28th and the Park served as a grand stage for the July 4th celebration. Our contractor continues to complete minor “punch list” items and additional scope items that have been added to the project. We will monitor the landscaping during the warranty period, as well as mechanical and electrical equipment to make sure it performs as planned.

Downtown Park – NE Entry

Work is underway on this funded CIP project, which is to create a park entry at the northeast corner of the park at the SW corner of Bellevue Way and NE 4th. We have secured a consultant team to prepare design alternatives. A kick-off meeting is scheduled for late September.

Kelsey Creek Playground Replacement

The old playground area has been converted to a turf picnic area, and the new, relocated farm-themed playground is complete and opened for play on June 26th.

Marymoor Park Transfer

The project remains on-hold. We have explored options to transfer the City-owned portion of Marymoor Park to King County to allow the County to enter into an agreement with a local soccer organization to redevelop the existing softball fields into a soccer complex.

Meydenbauer Bay Phase 1 Park Development

Construction is approximately 25% complete, with expected completion at the end of 2018. Foundation and abutment walls for the beach house are complete, and the initial retaining wall is under construction. Site grading is underway and in-water work began July 17. Sewer connections and piling installations for the pier are complete, and shoreline work is ongoing. We discovered and removed a large plume of contaminated soil from the site that was apparently the result of a leaking diesel line used to fuel coast guard ships during the 1940's. We are currently working with PSE to finalize plans to underground the overhead wires along Lake Washington Blvd, with work scheduled this fall. Plans are also being finalized to remodel the Whaling Building to include public restrooms, a meeting room and small boat rental facility. This project will be complete when the remaining park is complete.

Park & Natural Areas Levy Projects Summary

- **Synthetic Sportsfield at Wilburton Hill Park:** Project complete.
- **Synthetic Sportsfield at Newport Hills Park:** Project complete.
- **Lewis Creek Park Picnic Area:** Project complete.
- **BYT Construction:** Project complete, including a new video wall. We received approval to convert a 4Culture grant from Ivanhoe to BYT to convert a storage room into another rehearsal space. Work on that project is expected this fall.
- **Bellevue Airfield Park:** Site analysis and initial schematic design is complete. The cost estimates for Phase 1 are significantly over the anticipated budget, so we continue to explore schematic design options and costs to determine the Phase 1 scope of work.
- **Botanical Garden Projects:**
 - **Ravine Garden:** Project complete.
 - **Visitor Center:** Project complete.
- **Neighborhood Parks:**
 - **Bridle Trails/140th Ave Property:** Project complete.
 - **Bridle Trails Corner Park:** Project complete.
 - **Newport Hills Tyler/Patterson acquisition:** Project complete.
- **Downtown Park “Complete the Circle” Development:** 99% complete
- **Hidden Valley/Boys & Girls Club Partnership:** Complete
- **Lake Sammamish Neighborhood Park:** No activity.
- **Surrey Downs Park Development:** See below.

Surrey Downs Park Development

Design is ongoing and permit review is underway. Subject to light rail construction progress, park construction is anticipated to start in the spring of 2018. Staff is working with the adjacent neighbors to address property encroachment issues and to identify an appropriate boundary fence to install prior to construction. Letters have been sent to all adjacent residents and staff continues meeting with the neighbors.


The box will take anywhere from 2 weeks to 8 weeks to arrive, depending on what is selected.

Hello,

We are interested in discussing a potential pilot infill project between the City of Bellevue and the Bellevue School District. Bennett Elementary School parents and PTSA, as well as the surrounding community of Tam O' Shanter, Lochmoor, Tam O' Shanter West, West Lake Sammamish, and the neighborhoods of southeast 24th St have voiced their interest over the last year for an alternative to a rubber crumb infill turf field at Bennett Elementary. The community has voiced concerns over inconclusive rubber crumb studies on the potential exposures to children via hand mouth and VOC's, as well as the leachates of the vulcanized rubber crumb into our watershed, particularly zinc which is lethal to aquatic life in developing stages. The Bennett PTSA recently held a meeting to vote on whether or not they would support an alternative, such as cork, to rubber crumb and voted unanimously in favor. The proposed field is to be placed by the end of August and the infill material is currently proposed to be coated rubber crumb, as are all of the new future fields in the Bellevue School District.

We have discussed our interest in an alternative to rubber crumb at the elementary school level. The district has been open to discussion of alternative infills, but have expressed concern over the durability of the alternatives in the PNW climate. Seattle Public Schools, Seattle Parks and Rec, Shoreline Parks and Rec, Anacortes High School, Lakewood High School, Burien High School, Vashon Island High School, South Kitsap High School, Anacortes High School, Kennedy Catholic High School, and Mercer Island High School have already placed or are in process of using an alternative infill. We are proposing a joint collaborative pilot project at Bennett Elementary School for the City of Bellevue and the Bellevue School District to monitor the function, effectiveness, and durability of an alternative infill to rubber crumb. The

municipalities can monitor the infill over the duration of the field lifespan of 8-10 years to determine whether it is a potential option for other future turf fields in the area.

We have attached a research analysis that supports the use of an alternative infill such as Purefill cork by Field Turf.

Please let us know if this is an idea that the city would be interested in collaborating in.



However, FieldTurf representative, DA Hogan, reported that coated crumb rubber would've performed in the same way at Anacortes. No other problems reported during wettest winter in recorded history (2017).
- 4 - Coated crumb rubber can reach temperatures over 120 degrees and documented to cause second degree burns in less than 10 minutes if outside temperatures exceed 80 degrees F. On 5/23/17, when the outside temperature was 79 degrees, the turf surface was measured at 128 degrees.
- 5 - Per Melissa DaVita and Jack MacLeod's 5/2 update to BSD, amended sand is the lowest cost option

- 7 - Lifetime costs of coated rubber crumb is \$2,000 more expensive than cork per school. At 26 schools, this total s \$52,000 additional approximately every 10 years.
- 8 - Infill products have consistent GMAX ratings. Per BSD, not an issue between the options. At South Kitsap High School (where a natural cork/coconut infill is used players and coaches give it rave reviews: "They swear our incidence of concussion is lower than when we play away games." (<https://www.parentmap.com/article/artificial-turf-crumbs-cancer-risk>))

9 - Per Cushion Fall Sport (crumb rubber manufacturer) website (<http://www.cushionfallsport.com/safer-for-the-environment/>) the polyurethane coating reduces "volatile organic compounds (VOCs) by 71 percent and heavy metal run-off by 80 percent." The product admittedly still releases VOCs into the air and some heavy metal compounds into the water supply.

Additionally, elementary school aged children playing during recess can not follow the guidelines recommended by the Department of Health, including washing your hands after playing on the field and before eating; taking off any equipment outside or in the garage; showering after play; quickly cleaning any cuts or scrapes; and spitting out any crumb rubber that finds its way into your mouth.

10 - While natural product, pesticides used to maintain

11 - Per Melissa DaVita and Jack MacLeod's 5/2 update to BSD, natural products are favorable

12 - While there have not been studies of the organic cork infill, given the known chemical make-up of cork versus that of used tires, it is not a prevalent concern

13 - Contains over 90 chemicals, long term impact on health used by elementary school children unknown. Current studies include: Environmental Protection Agency (EPA), the Centers for Disease Control and Prevention and the Consumer Product Safety Commission have launched federal research studies.

Additionally, California's Office of Environmental Health Hazard Assessment is conducting a study. The final report is expected in 2019.

Additional concerns present regarding possible contamination of the water supply if the crumb rubber particles enter storm drains.

14 - Per Melissa DaVita and Jack MacLeod's 5/2 update to BSD, grass requires significant efforts to maintain, including mowing, fertilizer, watering and reseeding.

15 - Per Melissa DaVita and Jack MacLeod's 5/2 update to BSD, lines on field don't last and requires ongoing maintenance to re-level for ruts. As a positive, has a higher density and doesn't blow in wind.

16 - As mentioned in note 3, there is potential to need to re-spread the infill in rare weather occurrences.

Additionally, Enatia, which as cork infill on the playground has an issue with turf "seams" appearing. However, turf seams are a result of traffic patterns and are not dependent on the infill material, i.e. turf seams would have appeared with crumb rubber infill as well.

17 - As mentioned in notes 3 and 15, maintenance issues reported for cork infill (re-spreading and seam) would also occur for coated rubber crumb. Additionally, coated rubber crumb would need to regularly be watered down on hot days to cool down surface temperatures (the temperature reduction only lasts for 10-20 minutes after watering). It is also recommended to regularly sweep infill material from play yards to prevent it from entering the water supply.

(2) Installion costs for coated crumb rubber pulled from multiple sources average to \$.85/square foot. Per May 2, 2107 BSD board meeting all weather turf field update, cork infill was \$.70/square foot more expensive than coated crumb rubber. However, a CA manufacturer quotes the costs of cork as only \$.60/square more expensive. To be conservative, I have estimated the additional installation costs at \$.70/square foot more expensive.

(3) Fields to be tested every 3 years over 10 year lifecycle. David Anderson, a toxicologist from Envirostress, estimated the costs at approximately \$3,000. Potential to exceed estimate if requirements go beyond basic chemical testing.

(4) Coated crumb rubber must be bagged on site and transported to a hazardous waste facility. Estimated cost per disposal from 3 different sources averaged to \$.50/sq ft. According to the Synthetic Turf Council, recycling crumb rubber infill is usually more costly than disposal.

Organic cork is not known to have any disposal fees. It can be used on site for top dressing natural grass or or soil enrichment.
