Note: Plats of 10 or more lots and Planned Unit Developments within the Issaquah or Renton School District are required to pay half of their Issaquah or Renton School District Fee at the time of final approval. The balance is due at the issuance of each building permit.

The current full fee for the Issaquah School District is \$15,510 per single family residence and \$3,514 per multifamily unit. The current full fee for the Renton School District is \$2,161 per single family residence and \$4,257 per multifamily unit.

Effective 1/1/2024

- We charge the hours of review and inspections against the deposit. If the deposit is depleted, you will receive a bill monthly for any additional hours. We will refund any remaining deposit balance.
- A \$330.30 fee is collected at submittal for one Land Use Notice Sign. If additional signs are required, you will be billed.
- A \$330.30 fee is collected at submittal for one Land Use Notice Sign if the application is for an amendment.

Note: A fee of \$3,805 will be collected for each Transportation model run.
