Additional Fees and Charges

Water Main Shut-Off charge for work on Utility Extensions -- billed at \$187 per hour and \$219 per hour for overtime.

Direct or Regional Facility charges -- per ordinance or administrative rule

Latecomer Administrative Fee -- 3% of Latecomer Fee

Work in other than Bellevue or King County requires a separate ROW use Permit for that jurisdiction.

We charge the hours of review and inspections against the deposit. If the deposit is depleted, you will receive a bill monthly for any additional hours. We will refund any remaining deposit balance. Fire Department Review is billed at \$200 per hour.

*The Cascade Water Alliance has adopted a Regional Water Capital Facilities Charge (RCFC) increase, effective on January 1, 2021. This charge applies

to all new or upsized domestic and irrigation water meters. The table below lists the one-time charge due upon application for meter installation; or, prior to construction approval for meters larger than 2", which are contractor installed. Credit is given for removed meters. Stand-alone fire sprinkler connections and meters used to deduct volumes for sewer billing purposes are not counted as Cascade Equivalent Residential Units (CERUs), and no RCFC is imposed since these meters do not increase system demand.

*For single-family customers, domestic "combination" meters that are oversized to provide for both domestic use and fire protection through installed fire sprinkler systems will be charged according to the meter requirement for domestic demands absent such fire protection requirement; the incremental meter sizing required solely for fire capacity will not be subject to RCFCs. Such combination meter will be assumed to be actual size minus one size increment. Size reductions larger than one increment will require additional documentation. Incremental meter sizing to increase flow for reasons other than fire protection do not qualify for a reduced meter size for CERU calculation purposes.
